

Statutory Declaration

- Any information contained in my Nomination Form for the 2026 University of Sydney Union (USU) Annual Board Elections is true and correct to the best of my knowledge and I affirm the validity of the information provided.
- I have read the USU Constitution, Regulations, Candidate Handbook and any Duty Statements for Board Directors, and I have also read the Constitution and Bylaws of USU Ltd as applicable to the 2026 transitional governance arrangements. I agree to comply with those documents from the time of my nomination to the Declaration of Final Results and, if elected, for so long as I hold office in the relevant entity. Additionally, I agree that by signing this Statutory Declaration, I will uphold the ethical, conduct and expectation requirements contained in the most recently approved version of the Board Charter, to the extent applicable to my role as a candidate and, if elected, as a director.
- I acknowledge that, under the 2026 transitional governance arrangements, the outcome of the 2026 USU Board Election will also satisfy the 2026 election requirements for directors of USU Ltd. I further acknowledge and agree that, if elected in the 2026 USU Board Election, and subject to my consent and eligibility, I will hold office as a director of the unincorporated USU in accordance with its governing documents and, from 1 July 2026, will also hold office as a director of USU Ltd in accordance with its Constitution and Bylaws. I acknowledge that these offices may be held concurrently during the transitional period until the winding up of the unincorporated USU is completed.
- I understand that attendance at the Compulsory Candidate Briefing for Candidates on Thursday 23rd April 2026 at 6:00pm (AEST) is compulsory and I attest that I will attend this session, save in the event of extreme illness or other extenuating circumstances beyond my control. I understand that circumstances beyond my control do not include such things as holidays, overseas travel, birthday celebrations, work commitments or other similar commitments.
- I understand that to be eligible to receive a USU Electoral Grant, I will be supplied with and be required to sign an Electoral Grant Scheme Agreement and will do so.
- I understand that if the Returning Officer determines that there has been a breach of the Regulations, by a candidate, or by a supporter of a candidate or by a person on behalf of a candidate, they may impose a penalty or penalties in the form of a formal warning, suspension of a person from campaigning, suspension of a candidate's campaign or disqualification, and/or repayment of issued or unspent grants. I agree that if I am found to be in breach of the Regulations, I will return any grant funding as required.
- I understand that, if elected in the 2026 USU Board Election, I will be required to attend all of the following as part of assuming and discharging my responsibilities as a director of the unincorporated USU and, where applicable, as a director of USU Ltd:
