Why am I informed here about the processing of my personal data?

The protection of your personal data, so-called personal data, is your fundamental right. Therefore, we may only process your personal data if we are permitted to do so by law. The General Data Protection Regulation (GDPR) provides such legal permission. We take the data protection requirements of the GDPR into account in our processes and procedures. Among other things, it requires us to inform you about which personal data we process for which purpose and for how long.

Information on typical data processing

Server Log Data

In order for our web server to be able to fulfill your data request, our web server must know your IP address, i.e. "process" it. Every time our website is accessed, our system will automatically collect data and information from the system of the calling device. The data is processed via SSL. This data is usually automatically stored in a log file. The said data will not be stored together with any other personal data pertaining to the user.

What data do we process when you submit your application for the "Young Sports Media Talents" project

Deletion/ Retention

You have the option to withdraw your application at any time. Thereafter and generally, personal data collected from you will be deleted once it is no longer needed for the purposes for which it was collected, unless you have explicitly consented to further use and extended storage of your data, or we are required or entitled by law to retain the data for a longer period. In any case, we will store your data until after the completion of the Rhine-Ruhr 2025 FISU Games, i.e., at the latest until **31 August 2025**. Your right to withdraw consent or to object remains unaffected (please see in detail under *What rights do I have?*).

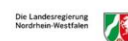

Travel & accommodation

The Rhine-Ruhr 2025 and the International University Sports Federation (FISU) will cover the costs of travel and accommodation. The data provided will be used to book the tickets and make the hotel reservation.

Project Advertising

Rhine-Ruhr 2025 will take measures to promote the project in a targeted manner. The aim is to raise awareness of the project and make its results available to the public. If this concerns measures in relation to the participants that were not specified accordingly in the application form or otherwise in the project presentation, we will generally ask for your consent beforehand (legal basis: Art. 6 para. 1 lit. a GDPR).

Creating Recordings

As part of the Rhine-Ruhr 2025, image and sound recordings (hereinafter referred to as "**recordings**") are made. You can also be the subject of these recordings and be recognizable on them. We process your data in order to present Rhine-Ruhr 2025 to the outside world and to fulfil our obligation to our partners, sponsors and press and media representatives. Even after the end of the project, regardless of the legal reason for your assignment, we will continue to use the recordings. This allows us to assign your rights via the conditions of participation.

The legal basis for the creation and publication of recordings is Art. 6 para. 1 lit. b GDPR.

Communication

In order for us to be able to contact you by calling you, sending you an email, a text message or a letter, we process your communication data. In this context, we process your data for the purpose of providing important information regarding your participation in the project. Without providing this data, we will not be able to send you the relevant information regarding your participation in the project. The legal basis for this is Article 6 para. 1 lit. b GDPR.

art. 16 GDPR, you have the right to request the completion of data concerning you or the correction of inaccurate data concerning you.

In accordance with art. 17 GDPR, you have the right to demand that relevant data be deleted immediately or, alternatively, to demand a restriction on the processing of the data in accordance with art. 18 GDPR.

You have the right to request that the data concerning you that you have provided to us be transferred in accordance with Art. 20 GDPR and the right to request a transfer to other controllers.

Art. 7, para. 3 GDPR, the right to revoke consent given at any time without giving reasons with effect for the future. If you withdraw your consent, we may no longer continue the data processing based on this consent in the future. Please address your revocation to datenschutz@rhineruhr2025.com.

If we process your data in accordance with Art. 6 para. 1 lit. f GDPR on the basis of legitimate interests, you can object to the future processing of your data in accordance with Art. 21 GDPR at any time, insofar as there are reasons for this that arise from your particular situation. However, we cannot always comply with your objection, for example if we are required by law to process it.

If you believe that we have not complied with data protection regulations when processing your data, you can contact the competent supervisory authority with a complaint under Art. 77 GDPR.
