Data Protection Note

Accreditation at Rhine Ruhr 2025 FISU Games

Data Controller	<p>Rhine-Ruhr 2025 FISU Games gGmbH, Nördlicher Zubringer 9-11 40470 Düsseldorf Germany ("Rhine Ruhr 2025") is the data protection controller for the accreditations of, in particular, national media representatives, National Technical Officials ("NTOs"), volunteers, service providers and other correspondingly communicated persons (e.g. employees of Rhine Ruhr 2025) for the Rhine Ruhr FISU Games 2025 (and/or events and activities taking place before or after the Rhine Ruhr FISU Games 2025 and in this context; hereinafter "the Event").</p> <p>The accreditation of other groups of persons in connection with the event is carried out directly by the Fédération Internationale du Sport Universitaire ("FISU") as the umbrella organisation of the event (e.g. delegations of athletes and other officials, international media representatives, etc.) on a separate basis and as independent data controllers within this framework.</p>

Categories of personal data	<p>When applying for accreditation, applicants (hereinafter referred to as “data subjects”) are asked to provide the following personal data, depending on the Client Group they belong to:</p> <ul style="list-style-type: none"> • First Name(s) • Last Name(s) • Date of Birth • Country of Birth • Current registered address (street, postcode, city) • Nationality • Contact details (f.e. mobile number, E-Mail) • Passport-style photo • where required, Identification document (hereinafter ID)-/Passport number and issue/expiry date, if applicable • where required, emergency contact details where required, information on any medical or dietary or other requirements (optional)
Purpose of data processing	<p>The personal data will be collected and processed to:</p> <p>(i) process accreditation applications (also referred to as registration forms) and, if such an application is successful, issue the data subject with an accreditation allowing access to the event (as defined in the Rhine Ruhr 2025 General Terms and Conditions for Accreditation);</p> <p>(i) (ii) implement any safety and hygiene measures relevant to the event, if necessary.</p>

Legal Basis	<p>The processing of personal data by Rhine Ruhr 2025 is required to:</p> <p>(i) fulfill the contract between Rhine Ruhr 2025 or FISU and the data subject or the company acting as the data subject's contractual partner, as well as Rhine Ruhr 2025's General Terms and Conditions for Accreditation (see Art. 6 (1) (b) GDPR) and</p> <p>(i) (ii) assist the data subject with visa or accommodation matters (Art. 6 (1) (f) GDPR).</p>
Categories of data recipients	<p>The personal data collected and processed as part of the accreditation process will only be processed by responsible employees within Rhine Ruhr 2025. The personal data entered as part of the accreditation application/registration form via the FISU accreditation portal at https://app.gms-rhineruhr2025.com/#/reg/my-info will also be accessible to FISU, which acts as the operator of the accreditation portal and data processor in this context, and to BORNAN SPORTS TECHNOLOGY, SL, C/ Marie Curie, 19, 6th floor, (modules 6.5 and 6.6), 28521 Rivas-Vaciamadrid, Madrid, Spain, as the technical provider of the accreditation portal and sub-processor of FISU, as well as other third parties commissioned by Rhine Ruhr 2025 to assist in production of the accreditation cards (in particular, cards-x GmbH, Kleberstraße 2, 40822 Mettmann, Germany, for printing the accreditation cards).</p>
Transfer of Data	<p>Certain personal data may be transferred to the relevant authorities based on legal provisions and obligations, as well as in the context of safety and hygiene measures relevant to the event and for law enforcement purposes, in particular for administrative procedures or requests from the relevant authorities regarding the fulfilment of tasks within their territory.</p>

	<p>Rhine Ruhr 2025 takes appropriate security measures when transferring personal data to the above-mentioned parties in a country that does not ensure adequate data protection under applicable law (pursuant to Articles 44 et seq. of the GDPR).</p>
Your rights	<p>As a data subject, you have certain rights in connection with the processing of personal data by Rhine Ruhr 2025 as data controller under Chapter III of the GDPR, depending on the legal basis and purpose of the processing. Duration of data retention	<p>Rhine Ruhr 2025 will not collect and process personal data for longer than necessary for the purposes stated above, unless the data subject has consented to longer storage; these personal data will continue to be required for administrative or legal procedures related to the event or, where appropriate, for the prevention or detection of unlawful activities.</p>
