## **ENERGY PARK obtains the third LEED PLATINUM certification**

Buildings of the Business Park among the 80 platinum buildings in Europe and 231 worldwide

Milan, February 2016 – **COIMA SGR** – leading independent company in the asset management of real estate investment funds on behalf of Italian and international institutional investors – confirms itself as a key player in Italy with regard to sustainability. Energy Park, acquired by COIMA SGR in April 2015, officially obtained the LEED PLATINUM certification, thus bringing to 22 (with over 400,000 sq.m.) the number of green buildings managed by COIMA SGR including Bosco Verticale, UniCredit Tower and Gioiaotto.

The LEED certification, granted by the Green Building Certification Institute (GBCI), is one of the standards that promotes and provides a global approach to sustainability applied in over 100 countries worldwide and assigns, on the basis of specific characteristics, four different ratings: Base, Silver, Gold and Platinum.

Low impact on the surroundings and the site area, the presence of rainwater harvesting systems, the use of energy from renewable and local sources, the choice of natural materials with high levels of recycled content and regional materials are just some of the basic parameters for obtaining the LEED certification. These requirements must be complied with during the design and construction stages up until the completion of works.

Energy Park obtained all the points submitted to the review authority, proving the quality of the work carried out during all development phases of the project. The LEED Platinum certification was achieved, for example, thanks to:

-the use of native and adaptive species that preserve the biodiversity of the area
-the use of rain and groundwater for the irrigation of green areas
-6.63 % of parking spaces reserved to "low-emitting and fuel-efficient vehicles"
-100% of RECs certified green energy for common areas and outdoor lighting
-89.5% of construction waste NOT sent to landfills
-21.2% of recycled content in construction materials
-77.33% of regional materials, i.e. they extracted, processed and manufactured regionally
-over 30% reduction in water use compared to the reference building
-over 50% reduction in water use for landscape irrigation
-55% reduction in overall water use for landscape irrigation

Energy Park, a suburban park covering 61,400 sq.m. dedicated to office/laboratory use, developed by SEGRO with a project by Studio Garretti Associati and completed halfway through 2014, is located in Vimercate, less than 20 kilometres from Milan, in a strategic position well connected to both the major thoroughfares of northern Italy as well as the capital of the Lombardy region, today representing a technological hub of excellence. It currently generates gross annual rent amounting to €9.6 million from the various tenants, which include Nokia and a series of other innovative international companies operating in e-commerce and high-tech industries, such as Esprinet, SAP, DNV, Nobel Biocare and Stanley Black & Decker.
