### COIMA SGR FINALISES THE SECOND KKR ACQUISITION IN ITALY WITH THE RETAIL PARK "LE VELE"

### KKR invested over 100M to date in Italy with COIMA SGR

## The second transaction has been executed on behalf of the KKR fund II targeting Italy as one of the main market for 2017

# Le Vele retail park have been acquired for 57 million euros for a commercial area of over 25 thousand square meters

*Milan, December 20^{th} 2016 - COIMA SGR - a leading independent manager of real estate investment funds on behalf of Italian and international institutional investors - finalised together with KKR - a world-leading investment firm - the acquisition of the Retail Park "Le Vele".* 

This is the second transaction that COIMA SGR and KKR performed together in 2016.

Opened in 2003, the park is located near **Lake Garda** in Desenzano. Strategically positioned between the city centre and the train station, it attracts more than 5 million visitors every year.

In recent years, the Park has **continued growing while maintaining a stable tenancy**, with brands such as H&M, OVS, OBI, Trony as well as other Italian and international leaders. The surface area totals approximately 25,220 square meters and consists of more than 32 units.

The acquisition was finalised by **COIMA Core V Fund, which is backed by KKR Fund** and focuses on retail acquisitions.

The purchase price amounted to **approximately 57.2 million euros**. The Strategy is to consolidate the park through a medium-term growth plan.

Over the last 12 months, **COIMA** has experienced significant growth: it has expanded **its team of professionals** by 25%, from 115 to 150; it has raised **over 1 billion euros** from Italian and international institutional investors (numbering over 100, of which more than 60% are foreign); and in the last 12 months has finalized **over 1 billion euros' worth of acquisitions**.

Its main transactions include the acquisition of an 80 million euro property in **via del Corso**, Rome, as well as several assets in Milan: the **headquarters of BNP Paribas** (together with Qatar's sovereign fund) in piazza San Fedele, next to the Galleria and piazza Duomo, for more than 80 million euros; **Palazzo Turati** (together with Azerbaijan's sovereign fund), located in the historic business district, for over 100 million euros; the headquarters of the **Feltrinelli Foundation and Microsoft** in the newly renovated Porta Nuova district, for approximately 60 million euros; and the building previously occupied by INPS (Italy's National Social Security Institute) in **Via Melchiorre Gioia 22** (together with Abu Dhabi's sovereign fund), next to Porta Nuova and worth 200 million euros.

During the acquisition process of "Le Vele", **COIMA SGR** was assisted by Chiomenti Studio Legale as legal and administrative advisor, Studio Simonelli as tax advisor, and COIMA as technical advisor.

**COIMA SGR,** authorized by the Bank of Italy in 2007, is a leading independent company in the management of real estate investment funds on behalf of Italian and international institutional investors.
