

General

1. The promoter is Lendi Group Distribution Pty Ltd (ABN 27 105 265 861) of Level 28, 225 George Street, Sydney NSW 2000 and its subsidiaries where applicable (**Promoter or Aussie**).
2. The Great Aussie Summer Giveaway (**Competition**) will run from 9:00 am AEDT 20 November 2023 to 11:59 pm AEDT 28 January 2024 (**Competition Period**).
3. This Competition is a game of chance.
4. Entry is only open to applicants who are Australian residents who are 18 years and over.
5. You will receive one entry into the weekly draw, if you, during the Competition Period:
