<b>Eligible entrants:</b>	Entry is only open to Australian residents who are 18 years and over.
<b>How to Enter:</b>	<p>To enter the Promotion, an Eligible Entrant must attend a full home loan appointment with an Aussie Broker or Buyers Agent during one of the Entry Periods outlined in the Draw Schedule in section 8 below. Entrants will be automatically entered into the draw corresponding to the date of their appointment. 1. Eligible Entrants agree and acknowledge that they have read these Conditions of Entry (and Schedule) and that entry into the Promotion is deemed to be acceptance of these

Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.

- i) From the valid number of entries drawn in each Monthly Prize Draw, as outlined in the Draw Schedule, will each win a \$10,000 prize.
