I am pleased to announce that Richard Lloyd has been appointed as the permanent Chair of IPSA for a five year term running until 31 August 2026. Richard joined our Board in December 2018 and brings a wealth of experience from the finance and consumer rights sectors.

This year we published our <u>Corporate plan for 2021-24</u>. Our vision is to enable MPs to focus on what really matters by providing an exemplary, seamless regulatory service. We will do this by focusing on four key objectives; improving our customer service, simplifying our policy, delivering financial value and growing our people.

Last time I wrote to you we had recently launched our new public website and I hope that you are finding it easy to navigate to find the information you need. As well as information about <u>MPs staffing and business costs</u>, you can find our <u>responses to Freedom of Information Requests</u>, <u>responses to Parliamentary questions</u> and information about <u>who we are</u>, <u>what we</u> do and <u>how we operate</u>. As part of our commitment to providing great customer service, we now have team members based across the UK to ensure that we are truly reflective of the people we serve.

Following the murder of Sir David Amess, and in light of the increased security threat to MPs, we are reviewing the information we publish, including data on travel and constituency surgery venue hire, to ensure that it does not create a risk to MPs. We postponed the publication of expenditure information due this month and temporarily removed descriptive detail from previously published claims on our website while the review is carried out. We expect the next publication date to be Thursday 20 January 2022.

In doing so we reviewed and confirmed the principles that guide our decisions in relation to MPs' pay in order to ensure fairness to both MPs and taxpayers.



Having considered the responses, we have decided to go ahead with the proposed temporary, bounded discretion.


What measures are in place to safeguard public money?
