Thank you for your time today and for sending through the requested documentation.

Please be advised, we have now processed the Property Amendment form IPZZ4411459. We have requested that our Finance team make a payment of £2,448.28 to pay the rent for the period 15/10/2020 -24/12/2020, we expect this payment will be included in tomorrow's payment run, payments typically take 3-5 business days to clear. From the 24/12/2020 a quarterly payment of £3000.00 will be made direct to the agent until 14/10/2025

Please note, from the correspondence provided I can see that the agent requests a unique reference is used. Unfortunately, our payment system does not accommodate individual reference preferences and so all rent payments are made using the reference 'IPSA Rent'.

I have requested that a copy of the remittance is emailed to [REDACTED] each quarter to help them allocate these payments. This will begin from 24/12/2020.
