"We welcome the greater transparency that has been built into the reformed expenses system under IPSA, meaning that much more information will be routinely published than under the old system. Given the cost and time for individual redaction, we can understand IPSA's decision not to publish itemised receipts."

"FOI requests for individual receipts can be made to IPSA. They would be dealt with on a case by case basis and personal information should be redacted where necessary."
