Within the framework of this contract, the Swift Service Bureau managed by BIL (Banque Internationale à Luxembourg) hosts the Swift infrastructure and the Swift applications for Banque Degroof Petercam Luxembourg and Degroof Petercam Asset Services.	The Swift infrastructure and Swift applications are hosted in Luxembourg by BIL (Banque Internationale à Luxembourg), a financial institution regulated by the CSSF in Luxembourg. Under certain conditions, the data may be made accessible on a confidential basis to a subcontractor of the BIL, which is in Poland.
<b>Execution of the operations related to some financial instruments (exchanged-traded derivatives, bonds, and equities)</b>	Execution of the relevant operations sent through the trading room of Banque Degroof Petercam Luxembourg by the trading room of Banque Degroof Petercam in Belgium	Within the framework of this contract, Banque Degroof Petercam in Belgium may have access to the confidential data stored in the IT systems of Banque Degroof Petercam Luxembourg for order routing purposes.	The access to the data is given to the employees of Banque Degroof Petercam in Belgium in charge of the operations in a confidential and secured manner via the core banking system or the order management system.
<b>My Degroof Petercam Institutionnel (MyDPi), online account access and order placement service</b>	Application linked to a computer licence accompanied by hosting, maintenance, and computer development services by Objectway BV relating to the MyDPi service subscribed to by professional agents in connection with the accounts of the clients for whom they act	Under this contract, Objectway BV hosts the application for the MyDPi service at EBRC in Luxembourg and provides maintenance and development services. Data that may be accessible are data related to the bank account and transactions of the clients (account number, balance, performance, history, counterparties, transaction details, ...).	The data is accessible to EBRC, a Financial Sector Professional (FSP) located in Luxembourg. Exceptionally, when interventions are required on the application; confidential data may be made available on a confidential basis to Objectway BV.
