

Rizo-Lopez Foods Dairy Products Expanded Recall Feb. 8, 2024



Feb. 8: Rizo-Lopez recalled several dairy foods due to listeria concerns. Products were sold at Albertsons, Costco, H-E-B, and Trader Joe's. Product(s) affected: Trader Joe's Cilantro Salad Dressing, Chicken Enchiladas Verde, Southwest Salad, and Elote Chopped Salad Kit.
