

October 2023 Product Recalls, Full List

Eye Drops from CVS, Target & More



Oct. 30: The FDA has recalled certain over-the-counter eye drops from brands like CVS Health, Leader, Rugby, Rite Aid, Target Up & Up, and Velocity Pharma, due to potential bacterial contamination that could cause serious eye infections or severely impair vision. Even though the FDA hasn't heard about anyone getting an eye infection from these products yet, they still want to exercise caution.

It's the second eye drops recall in 2023; we saw one for Ezricare brand drops in January 2023.

Products affected: The recall includes 26 over-the-counter eye drop products under these brands (view the full list):

- CVS Health
- Leader (Cardinal Health)

- Rugby (Cardinal Health)
- Rite Aid
- Target Up & Up
- Velocity Pharma

What to do if you have the products: If you have any of these eye drops, don't use them! Toss them in the trash or take them back where you bought them for a refund. If your eyes feel weird or hurt after using them, talk to your doctor or get medical help right away.

Don Miguel Foods Carne Asada Burrito

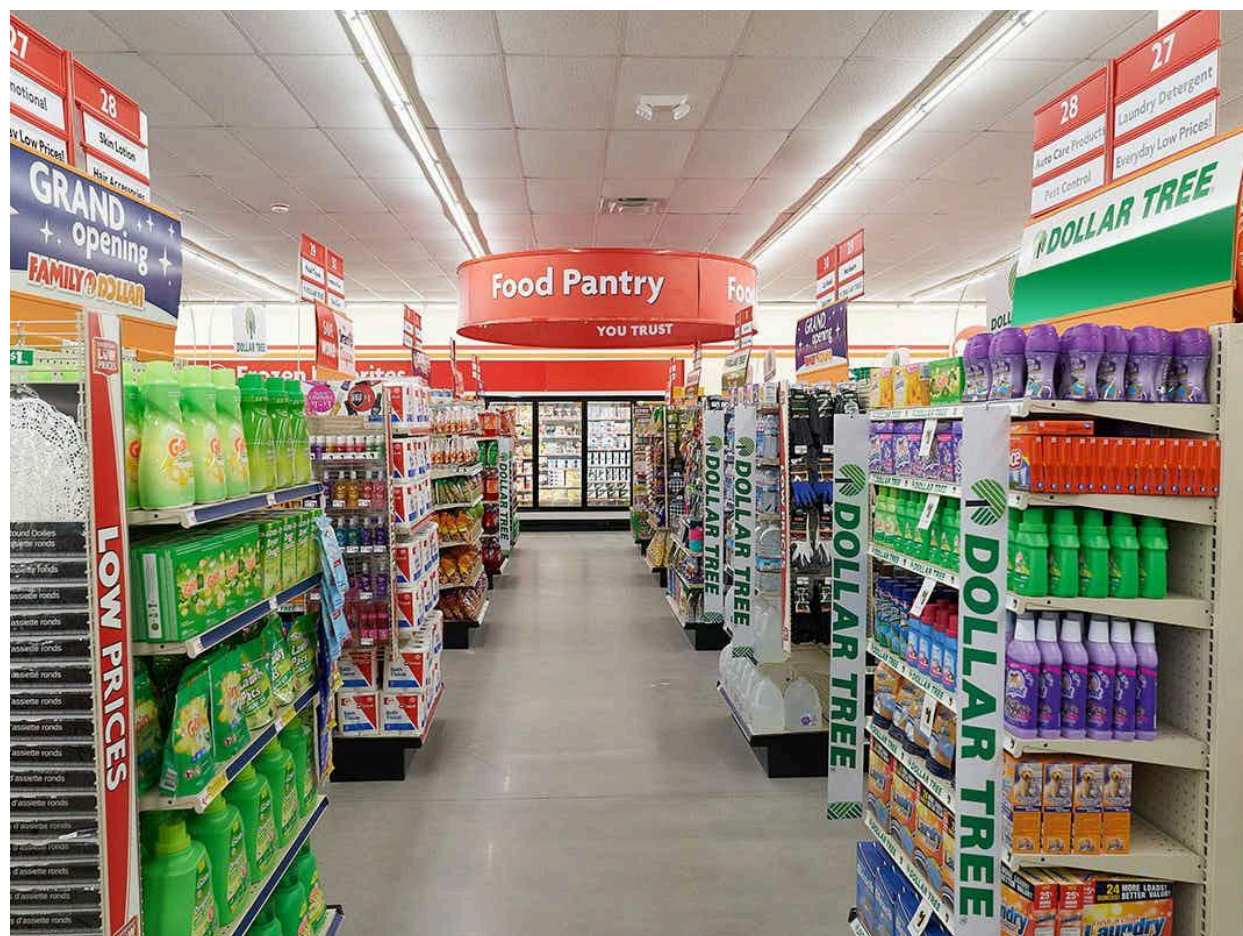


[Oct. 13](#): Don Miguel Foods has recalled a batch of their Carne Asada burritos, because they could contain *Listeria monocytogenes*, a bacteria that can make people really sick. This was found out through lab tests. Right now, no one has reported getting sick from eating these, but it's better to be safe and not eat them.

Products affected: The recall is for 7-oz. packages of “DON MIGUEL Hand Made BURRITO CARNE ASADA” with a date code of D23270 and an establishment number “EST. 20049,” made on Sept. 27, 2023.

What to do if you have the products: If you have these burritos, don’t eat them. You can either throw them away or take them back to the store where you bought them for a refund. Family Dollar Drugs & Medical Devices



Oct. 5: There’s a massive Family Dollar recall happening at stores in 23 states after the company discovered that a number of medicines and medical devices were stored at the wrong temperature. Although nobody has reported any illnesses from using these products, Family Dollar is issuing a recall and is offering refunds to anyone who bought these products.

Products affected: It's a long list of hundreds of drugs and medical devices, but they include a range of over-the-counter medications for cold, flu, and pain relief, oral care items like toothpaste and mouthwash, pregnancy and drug tests, first aid ointments, allergy relief tablets, digestive aids like antacids, and personal hygiene items like lip balm and eye drops.

These items were sold at Family Dollar stores in Alabama, Arkansas, Arizona, California, Colorado, Florida, Georgia, Idaho, Kansas, Louisiana, Mississippi, Montana, North Dakota, Nebraska, New Mexico, Nevada, Oklahoma, Oregon, South Dakota, Texas, Utah, Washington, and Wyoming.

What to do if you have the products: Take them back to the Family Dollar where you got them. No receipt required. If you have questions, call Family Dollar Customer Service at 844-636-7687 between 9 a.m. and 5 p.m. EST. If you're feeling sick or have problems, talk to your doctor.

Slime Licker Sour Rolling Liquid Candy



Oct. 5: The U.S. Consumer Product Safety Commission (CPSC) announced a recall for 70 million Toxic Waste Slime Licker Sour Rolling Liquid Candies due to a potential

choking hazard from the candy's rollerball. Candies were sold for \$2 to \$4 at retailers, including Walmart, Five Below, and Amazon between June 2015 and July 2023.
