

# November 2023 Product Recalls, Full List

## Diet Coke, Fanta, & Sprite



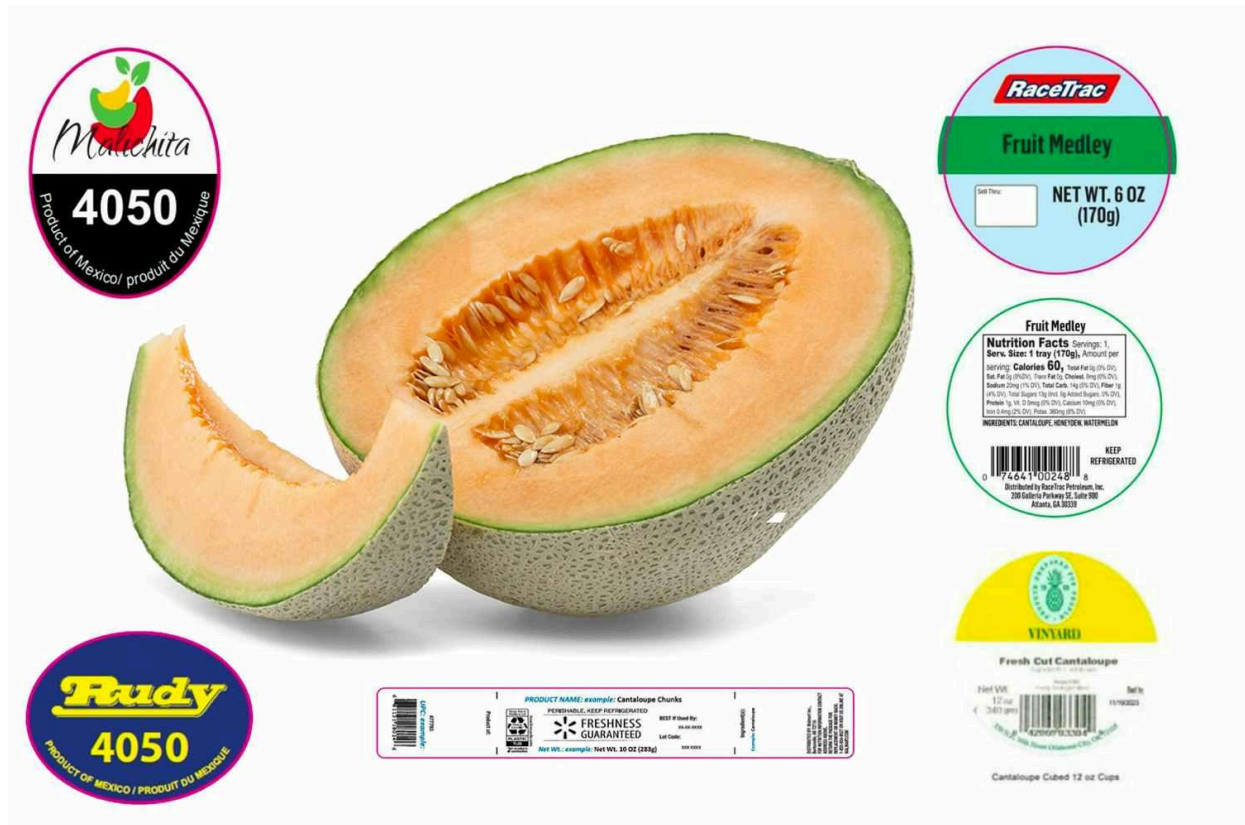
**Nov. 6:** One of Coca-Cola's bottling companies, United Packers, LLC, is announced a voluntary recall of certain soda products (Diet Coke, Fanta Orange, and Sprite) due to the potential presence of "foreign material" the cans. There was a similar recall in 2021, due to the possibility of metal bolts or washers in Minute Maid products.

### Products affected:

- 417 cases of Diet Coke (12 oz cans, 12-pack): Lot No. JAN2924MBD3, UPC# 49000028911, Best By 01/29/24.
- 14 cases of Fanta Orange (12 oz cans, 12-pack): Lot No. JUL2924MBD3, UPC# 49000030730, Best By 07/29/24.
- 1,557 cases of Sprite (12 oz cans, 12-pack): Lot No. JUL2924MBD3, UPC# 49000028928, Best By 07/29/24.

**What to do if you have the product(s):** If you have any of these soda packs, don't drink them. You can return them to the place you bought them from for a refund. ## Malichita Cantaloupe



**Nov. 24:** An investigation into a salmonella outbreak has led to a recall of cantaloupes — which have been linked to the infections. So far, around 100 people in 32 states have gotten sick from the contaminated fruits — with Arizona, Missouri, Minnesota, Wisconsin and Ohio having the highest number of cases. The infections have led to two deaths and 45 hospitalizations.

**Products affected:** The recall includes whole cantaloupes from the brands “Malichita” or “Rudy,” labeled as “4050,” and “Product of Mexico/product du Mexique.” These cantaloupes were sold at retail stores nationwide.

Also recalled are cut cantaloupe and products made from recalled whole cantaloupes:

- ALDI cantaloupe, cut cantaloupe, and pineapple spears with Best-by dates between Oct. 27-31.
- Vinyard cantaloupe chunks and cubes, fruit mixes, melon medleys, and fruit cups containing cantaloupe, most with a “Vinyard” label, and some with a red label with “Fresh,” sold between Oct. 30 and Nov. 10 in Oklahoma stores.
- Freshness Guaranteed and RaceTrac fruit products sold at select retail stores in multiple states.

**What to do if you have the product(s):** Consumers, restaurants, retailers, and wholesalers should not eat, sell, or serve recalled cantaloupe or recalled products containing cantaloupe. If you have frozen cantaloupe for later use, check to see if it’s part of the recall and discard it if uncertain.

## Publix Egg Custard Pie



**Nov. 17:** Publix has recalled their private label Egg Custard Pies sold in Monroe, Miami-Dade, Broward, and Palm Beach counties (Florida) between Oct. 20, 2023, and Nov. 16, 2023. The recall is issued because these pies may contain an undeclared coconut allergen. People with coconut allergies may risk serious, life-threatening allergic reactions if they consume these products.



**Products affected:** The affected product is the Egg Custard Pie with the product number 4141537891, sold between Oct. 20, 2023, and Nov. 16, 2023.

**What to do if you have the product(s):** If you have purchased the Egg Custard Pie with the mentioned GTIN and purchase dates, return the product to your local Publix store for a full refund. Call Publix at 1-800-242-1227 for more info.

## HMC Peaches, Plums, and Nectarines



**Nov. 17:** HMC Farms, has voluntarily recalled whole peaches, plums, and nectarines sold at retail stores between May 1 and Nov. 15, 2022, and between May 1 and Nov. 15, 2023, due to potential contamination with *Listeria monocytogenes*. This bacteria can cause severe infections, especially in vulnerable individuals. The recalled peaches have been linked to an outbreak where 11 people have gotten sick.

**Products affected:** The recall includes whole peaches, plums, and nectarines sold individually with PLU stickers or in consumer packaging. The affected products were distributed nationwide.

- Peaches, Nectarines, and Plums in two-pound bags branded as “HMC Farms” or “Signature Farms.”
- Individual Yellow Peaches with stickers labeled “USA-E-U” and bearing the numbers 4044 or 4038.
- Individual White Peaches with stickers labeled “USA-E-U” and bearing the number 4401.

- Individual Yellow Nectarines with stickers labeled “USA-E-U” and bearing the numbers 4036 or 4378.
- Individual White Nectarines with stickers labeled “USA-E-U” and bearing the number 3035.
- Individual Red Plums with stickers labeled “USA-E-U” and bearing the number 4042.
- Individual Black Plums with stickers labeled “USA-E-U” and bearing the number 4040.

**What to do if you have the product(s):** Check your freezer for the recalled fruit, refrain from consuming it, and dispose of it. For more info, call 844-483-3867, Monday-Friday, 8:00 a.m. – 8:00 p.m. Eastern Time.

### Apple Cinnamon Puree & Applesauce Pouches



**Nov. 16:** Elevated levels of lead, potentially causing acute toxicity, have been detected in certain apple cinnamon puree and applesauce products. Some kids got really sick eating certain brands of applesauce pouches, and now the FDA is pulling them off the shelves to keep everyone safe. Investigators believe the cinnamon is the source of the contamination. As of Nov. 16, 2023, there have been 34 reports of illness.

**Products affected:**

- WanaBana apple cinnamon fruit puree pouches (all lot codes and expiration dates): Sold nationally through multiple retailers including Amazon, Dollar Tree, and other online outlets.
- Schnucks brand cinnamon-flavored applesauce pouches and variety pack: Sold at Schnucks and Eatwell Markets grocery stores.
- Weis brand cinnamon applesauce pouches (specific lots of UPC 041497216123): sold at Weis grocery stores.

**What to do if you have the product(s):** If you've got any of these apple pouches at home, don't eat them or give them to anyone else. Toss them out or take them back to where you bought them to get your money back.

## IKEA LETTAN Mirrors



**Nov. 13:** IKEA is expanding the recall of LETTAN mirrors due to a laceration hazard. The plastic fittings that attach the mirror to the wall can break, causing the mirror to fall, posing a laceration hazard to consumers.

**Products affected:** The LETTAN mirrors affected by this recall include:

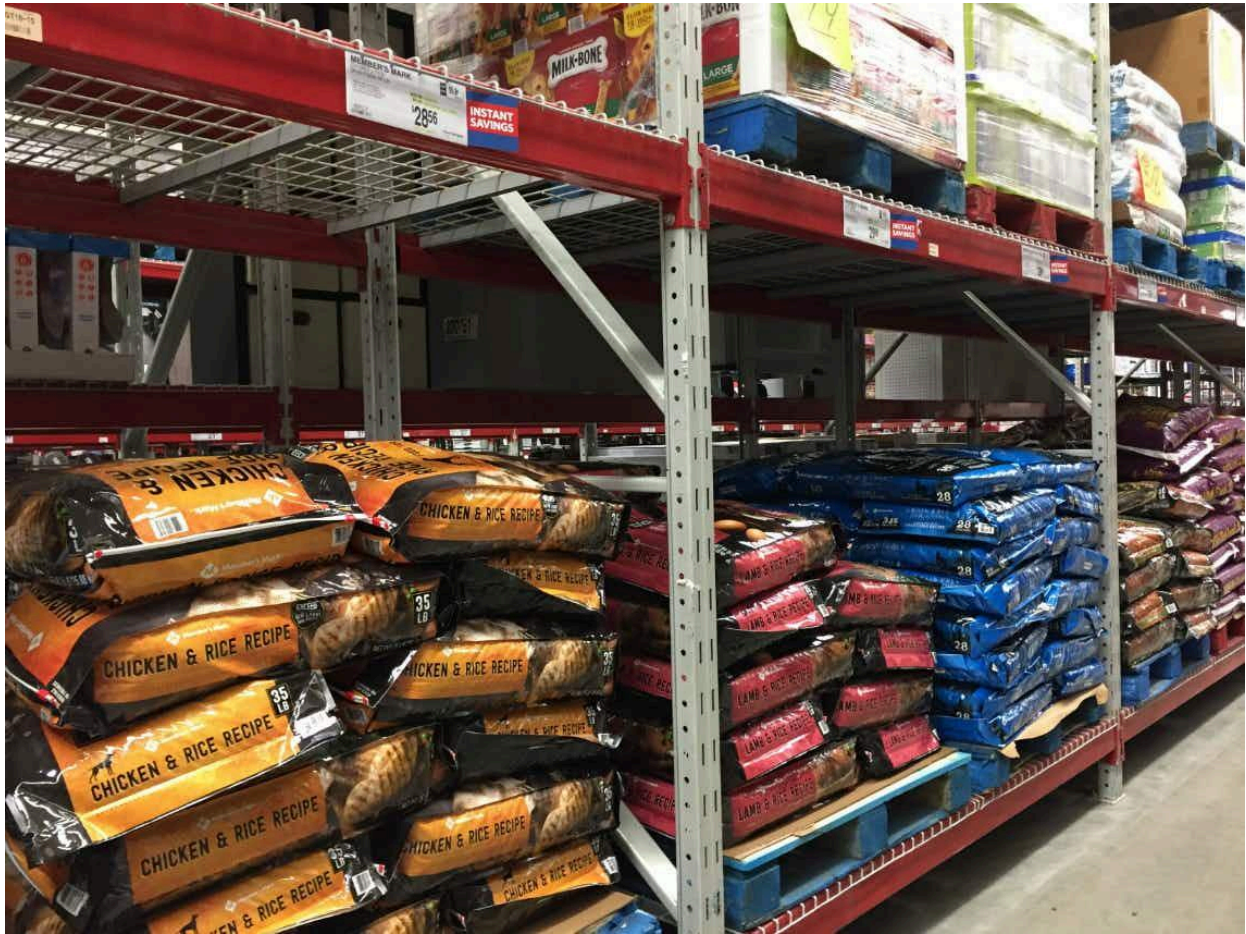
- LETTAN mirror 23 5/8×37 3/4 " (Article Number: 804.353.05)
- LETTAN mirror 31 1/2×37 3/4 " (Article Number: 804.353.10)
- LETTAN mirror 39 3/8×37 3/4 " (Article Number: 604.352.69)
- LETTAN mirror 47 1/4×37 3/4 " (Article Number: 304.353.03)

These mirrors have date stamps before and including 2105 (YYWW) and supplier number 21944, with date stamps before and including 2325 (YYWW).

**What to do if you have the product(s):** If you have any of the affected LETTAN mirrors, immediately stop using them. Contact IKEA online or by calling 888-966-4532 to order replacement wall fittings (part number 139298/1) free of charge. The number of fittings required will vary based on the size of the mirror, so be sure to check your mirror and assembly instructions before ordering. Alternatively, you can return the mirror to any IKEA store for a full refund, and proof of purchase (receipt) is not required.



## Mid America Dog & Cat Food



**Nov. 9:** Mid America Pet Food has issued a recall for 78 different pet food products due to potential Salmonella contamination after seven people fell ill with Salmonella Kiambu infection, possibly in connection with these products. While no pet illnesses have been reported, pet owners are advised to dispose of the affected products and watch their pets for any signs of sickness.

### **Products affected:**

Victor Super Premium Dog Food (Beef, Chicken, Lamb, Ocean Fish, Grain-Free, and other formulas)

- Bag Sizes: 5 lb, 15 lb, 30 lb, 40 lb, 50 lb
- Best by Date: Before 10/31/2024

Wayne Feeds Dog Food (Various Formulas)

- Bag Size: 40 lb

- Best by Date: Before 10/31/2024

Eagle Mountain Pet Food Pro Balance

- Bag Size: 40 lb
- Best by Date: Before 10/31/2024

Member's Mark (Beef & Brown Rice and Salmon & Sweet Potato Recipes)

*Cat food products affected:*

**What to do if you have the product(s):** If you have any of the recalled pet food, stop feeding it to your pets immediately. Dispose of the food securely to prevent other animals from accessing it. Clean and disinfect all pet-related items and surfaces. Wash your hands thoroughly after handling the product or cleaning up. Make sure you have your proof of purchase, like a receipt or a bank statement that shows the purchase, to help you get a refund.

## Tyson Fully Cooked Fun Nuggets



**Nov. 4:** Tyson Foods is recalling about 29,819 pounds of “Tyson Fully Cooked Fun Nuggets” (that are shaped like dinosaurs) due to possible contamination with metal pieces. The recall was initiated after consumers complained about finding small metal pieces in the chicken patty products.

**Products affected:** Check your freezer; the recall includes 29-oz. plastic bag packages of “Tyson FULLY COOKED FUN NUGGETS BREADED SHAPED CHICKEN PATTIES,” with a Best If Used By date of SEP 04, 2024, and lot codes 2483BRV0207, 2483BRV0208, 2483BRV0209, and 2483BRV0210. These items have the establishment number “P-7211” on the package.

**What to do if you have the product(s):** Don’t eat them! If you have these chicken nuggets at home, throw them away or take them back to where you bought them. ## Yoocaa Baby Loungers



**Nov. 2:** The U.S. Consumer Product Safety Commission has recalled Yoocaa Baby Loungers after they concluded that they don't meet safe sleep rules and can be dangerous for babies. They can cause babies to suffocate, fall, or get trapped because they're made the wrong way without proper stands and with sides that are too short.

**Products affected:** All Yoocaa Baby Loungers sold on or after June 23, 2022, on Amazon.com. Look for "SLEEPING SET" on the tag or check for a "LOT: YYYYMMDD" marking with dates of 20220623 or later on the package.

**What to do if you have the product(s):** Stop using the lounger right away and email Yoocaa at [yoocaa-cs@hotmail.com](mailto:yoocaa-cs@hotmail.com), or visit their website for a full refund and how to get rid of the product safely. Amazon and Yoocaa are also reaching out to people who bought them to help out.
