

Salad Kits and Taco Kits Expanded Recall Feb. 8, 2024



Feb. 8: Multiple stores have recalled [salad kits](#), [taco kits](#), [sandwiches](#), and [other products](#) due to the risk of listeria from Rizo-Lopez cheese. This is an expanded recall of Rizo-Lopez products after an initial recall on Feb. 5, 2024.
