Oregon Physical Therapist Licensing Program.

If you apply for a new Physical Therapist license or renewal in the state of Oregon between **December 9, 2024** and **December 20, 2024**, USN will reimburse your license fees up to **\$350**.

You must obtain an active Oregon Physical Therapist license AND be submitted by USN to a Physical Therapist position for the Oregon strike in order to receive reimbursement.

Qualified applicants will be reimbursed within 4-6 weeks upon proof of an ACTIVE verifiable online Oregon Physical Therapist license. If you have never previously completed an assignment with USN, you must provide a W-9 IRS form along with your receipt.

All Oregon license receipts and W-9 forms must be emailed to USNLicensing@usnursing.com by Friday, December 20, 2024.

Reimbursements are paid out via live check. Ensure your correct mailing address appears on your USN / Ingenovis Health profile and include your correct address in the email with your receipts.

Verification of Licensure

Send official verifications to Oregon from any state where you have ever been licensed and worked. Upload a PDF of the other state's online license verification while completing the online application, or contact the other state's board and request a license verification to be send to the Oregon Board.

FSBPT National Physical Therapist Exam (NPTE)
