1. Registration and scope of use				
1.1	Target group and cost liability	Addition stating the fee for our services is shown in the respective offer description.		
1.2	Information on the terms of acceptance of an unspecified registration process	Information on the registration process has been added here. This is now described in more detail. The registration process has not changed as a result.		
1.3	The user must provide truthful information	There is now a more detailed description of how the contractual relationship between the user and Zattoo is established, namely through our acceptance of the registration request.		
1.4	Scope of use only for personal purposes	Contract language, scope of information from Zattoo to the customer (mainly identical to the old point 2.6)		
1.5	Service availability	Scope of use only for personal purposes. The content is identical to the old point 1.4, only a linguistic change.		
1.6	End device availability	Service availability. This point is identical in content to the old point 1.5.		
1.7	Note on the presentation of offers	This point corresponds to the old point 1.6. However, there is now an addition stating that Zattoo can decide which devices are supported.

2.3	Order process	Here, only linguistic adjustments have been made to make the ordering process for chargeable services even clearer.			
2.6	Contract language, scope of information provided by Zattoo to the customer	The old point 2.6 has been deleted. The content can now be found unchanged in point 1.4.			
2.6		This new point 2.6 stipulates that Zattoo undertakes to provide the current software version of the respective subscribed products. However, a prerequisite is always compatibility with the operating system of the user's device.			
4. Cancellation po	4. Cancellation policy				
4.1	Right of cancellation	The deadline for cancelling the contract has been adjusted for the benefit of the users. Users can now cancel the contract within 14 days of the conclusion of the contract. The exception to the right of cancellation at the beginning of use has been deleted for the benefit of the users.

5.1	Disclosure of data by the user is not permitted	Here, only linguistic adjustments have been made. Nothing has been changed in terms of content.			
5.4	Section on the exclusive permission of use for private purposes	In terms of content, the permission of use is only granted for private purposes. The possible consequences of the legal violations mentioned are now clearly defined.

9.1	Liability on the part of Zattoo	This new point 9.1 has been inserted due to new legal regulations. Users can therefore assert warranty claims against Zattoo if Zattoo's services are defective.			
9.2	Indemnification by the user	This point corresponds to the old point 9.1.

10.1	Contract duration, renewal, information provided by Zattoo, termination options	The new provision in this point states the contract duration is extended for an indefinite period after the minimum usage period has expired. Termination options are now described in point 10.3. As a result, termination is now possible on a monthly basis after the initial contract period has expired.			
10.3	Repayment arrangements	This section now describes how to terminate a contract (termination conditions), which was previously included in point 10.1.			
10.4	not present	This point corresponds to the old point 10.3.

11.1	Transferability of rights and obligations arising from the contractual relationship	Transferability of rights and obligations arising from the contractual relationship. The user has a right of termination upon transfer, which applies from the time of the transfer.			
11.2	Notes on changes to the GTC and right to object	Additions have been made to this point to provide the user with even more detailed information about their right of withdrawal.
