

Application criteria:

This application may allow ICBC to register a vehicle that is not able to pass the mechanical safety inspection when the owner has a future intent of restoring the vehicle subject to the Commercial Vehicle Safety & Enforcement (CVSE) Director's Exemption.

The vehicle must meet the following conditions:

- be at least 25 years old and,
- be substantially intact to the point of the owner being in possession of over 50% of the original vehicle, in an assembled state,
- have no record of being registered in B.C., or have its most recent registration non-B.C.

Attachments

The following support documents must be attached to this application where applicable (submit copies and retain the originals for your records):

- □ Proof of ownership (Out of Province Registration or bill of sale to show continuity of ownership)
- □ ICBC Vehicle Record Search from Insurance Customer Service (ICS) required if a copy of its out of province registration is missing
- □ Bills of sale for all major component parts that comprise the 51% assembled
- □ Colour photos of vehicle showing the side view, front view, engine compartment, interior (including driver's compartment), and any visible VIN or serial numbers
- \Box APV9T (NO VIN sighting is required at this point note in Agent's comments).
- Note: Statutory Declaration (MV1484) must be notarized and submitted for any missing bills of sale and or documents.

How does the program work?

Step 1: Application to register the vehicle prior to inspection

ICBC may apply the CVSE Director's Exemption to postpone the mechanical safety inspection until after registration if your vehicle meets the application criteria and ICBC determines that your completed application satisfies the remaining requisites as outlined in the application (Registration Application for a Vehicle in Restoration).

The owner completes and submits the attached application, Registration Application for a Vehicle in Restoration (MV1458) with copies of all required documents and photographs to their Autoplan broker. The application will be reviewed by ICBC Vehicle Registration Support for acceptance.

If it is determined that the application does not meet the criteria for this program, the broker will be notified of the missing requirements.

If the application is accepted, the authorization for registration subject to compliance with the Director's Exemption will be provided to the broker who will contact the owner to complete the registration. Your vehicle will have a HOLD placed on it by ICBC to prevent your vehicle's operation on highway until it is completed and passes the provincial mechanical safety inspection if required.

Step 2: Once the vehicle is completed and passes the mechanical inspection

The owner submits the form called *Application for Verification of Description of Completed Non-Modified Vehicle* (MV1459) with copies of all original documents and photographs as noted on the form to their Autoplan broker. The owner must bring the vehicle into the broker's office to sight the VIN and complete the VIN section of the MV1459. The application will be reviewed by ICBC Vehicle Registration Support for acceptance.

If the application is reviewed and accepted, the HOLD will be removed by ICBC and authorization for licensing and insurance will be provided to the broker who will contact the owner to complete the transaction for the vehicle. If the application is not complete, the broker will be notified of the missing requirements.

Please note:

- Where a vehicle, during the restoration process is changed from the original description in the registration application for vehicles in restoration, ICBC may at its discretion change the registration status of this vehicle.
- A primary donor vehicle (forming 50% or more) that is branded non-repairable cannot be licensed and registered in B.C.
- Owners of salvage titled vehicles from another jurisdiction must contact a designated inspection facility prior to commencing any restorations.
- Any vehicle that no longer has an original manufacturer's public VIN must apply for a BC VIN (MV1325) prior to the Designated Inspection Facility (DIF) inspection. The VIN will be applied by the DIF when your vehicle passes inspection.

Important definitions:

For purposes of this application a major component part is defined as:

- frame, including subframe and chassis components
- cab and body assemblies including truck bed or box, doors, quarter panels, front or rear clip, hood or trunk lid
- drivetrain assemblies including engine, short block, transmissions, and transfer case
- seats, and
- tires and wheels

For motorcycles or trikes:

- frame
- · engine, and
- transmission

Eligibility criteria (confirm by checking box)
