Application for Modified Collector Motor Vehicle



Important - please read

Before completing this form, please ensure the vehicle meets ALL of the eligibility criteria in this application for a Modified Collector Motor Vehicle. **Incomplete applications will be rejected.**

If you wish to register a Modified Motor Vehicle only (without collector plates), do not use this form. Please complete an Application to Register a Modified Motor Vehicle (form MV1437).

Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible as a Modified Collector Motor Vehicle (see Step 3 of this application for condition requirements).

The modified motor vehicle will be registered with the model as "modif" and with an "altered" vehicle status.

A motor vehicle must be registered as a modified motor vehicle of a manufacturer's make if the motor vehicle (passenger or light commercial):

- · has the shell of body, coach or cab from the original manufactured motor vehicle; and
- has an altered body that resembles, but is no longer identical in appearance to the original body of the motor vehicle; or
- has had one or more of the following components replaced or altered:
 - suspension (if altered more than 2.5 cm)
 - frame
 - drivetrain
 - engine
 - steering
 - braking mechanical component (disk brakes)
 - fuel type.

Vehicles that are not eligible:

- · motorcycles;
- · motorhomes;
- vehicles that have had their body, coach or cab replaced with an aftermarket body, coach or cab; and
- · vehicles that are not fully assembled.

To qualify as a Modified Collector Motor Vehicle, the vehicle must:

- be registered in BC; and
- be a modified 1974 or earlier model; and
- be manufactured by a recognized vehicle manufacturer.

Eligibility Criteria

STEP 1 — Modified Collector Vehicle Information

☐ By checking this box, I confirm that the Modified Collector Vehicle:

- is registered in BC; and
- is a modified 1974 or earlier model; and
- is manufactured by a recognized manufacturer; and
- has had modifications made to the suspension, frame, drivetrain, engine, steering, braking mechanical components, body panels, or fuel type; and
- has the original vehicle manufacturer's body, coach, or cab; and
- is complete with all body panels, including any permanently attached fenders.

Provide Vehicle Identification Number(s) (VINs)

Inspect the vehicle and note all original manufacturer's public VINs and their locations.

Public VINs cannot be located underneath a vehicle; they must be clearly visible for sighting by an enforcement officer.

If you're unable to locate the original manufacturer's public VIN on the motor vehicle, you must:

 Complete an Application for BC Assigned VIN (MV1325), available from your broker or icbc.com; and submit the application with a cheque or money order for \$25 (payable to ICBC).

If the vehicle was manufactured to display 2 public VINs, but only one VIN is visible or legible, you must:

- Apply for a BC Assigned VIN (as above); or
- Stamp the original VIN using a handheld, hardened-steel, stamping die with characters no less than ¼" in height, in a visible portion of the engine compartment on the:
 - driver's side of the firewall; or
 - left side of the frame.

Vehicle Modifications

In order for the vehicle to qualify as a modified collector vehicle, one or more of the components listed below must have been replaced or altered from the original factory configuration.

STEP 2 – Support Document Requirements Copies of the following support documents MUST be attached to this application where applicable. Retain the originals for your records. Check all boxes that apply: ☐ A passed Private Vehicle Inspection Report (CVSE0013) or Commercial Vehicle Inspection Report (CVSE0014) from a Provincial Designated Inspection Facility. Exception: An inspection report is not required if the vehicle has previously passed a vehicle inspection for the modifications and no further changes have been made. ☐ All receipts, bills of sale, and paid invoices for major modifications made to the suspension, drivetrain, engine, steering, brakes, body panels, or fuel type. A notarized Unregistered Vehicles and Missing Signatures Declaration (MV1484) must be submitted for any missing receipts, bills of sale or paid invoices. ☐ A completed application for a BC Assigned VIN (MV1325) and cheque or money order for \$25, if applicable (see VIN section in step 1). A weigh scale certificate is needed if the modifications alter the net vehicle weight to ensure an accurate vehicle description and record, as required by legislation. ☐ Yes, the modifications have altered the net weight of the vehicle, weigh scale certificate attached. ☐ No, the modifications have not altered the net weight. STEP 3 — Vehicle Condition Requirements Regardless of the vehicle's age, it must meet ALL of the condition requirements to be eligible for the Collector Motor Vehicle Program. By checking all of the boxes below, I confirm the vehicle is in the following condition: □ Vehicle exterior – The vehicle's exterior is clean, detailed and in excellent condition with no dents, scrapes, chips, paint blemishes, bubbling, rust, or visible primer. If applicable, the convertible top has no damage and is in good working order. □ Vehicle interior — The vehicle's interior is clean, detailed and in excellent condition with no tears, stains, or significant wear. Minor neat repairs to the original upholstery are acceptable. ☐ **Vehicle repairs** — All repairs to the vehicle are completed according to professional practices and standards. ☐ **Engine/Engine compartment** — The engine and engine compartment is clean and detailed with no damaged, deteriorated or rusted parts. ☐ Stickers and advertising — The vehicle has no stickers or advertising of any kind. Exceptions are allowed to show affiliation with a collector vehicle club or for original dealer nameplates or decals that were dealer or factory installed. STEP 4 — Vehicle Use Declaration

Collector vehicles must not at any time be used for business use or driving to or from, or part way to or from, work or school.

By checking the boxes below, I confirm these two statements are true:

- ☐ The collector vehicle will be used solely for pleasure purposes, and cannot be used for general transportation, and will not at any time be used for driving to or from or part way to or from work or school or for any business use.
- ☐ I own or lease a **non-collector**, general transportation vehicle or I am the assigned operator of a company vehicle that is registered, licensed and insured in B.C. as the non-collector, general transportation vehicle.

Note: Upon licensing and insuring and on subsequent renewals, you will be required to inform your Autoplan broker of the licence plate number of the non-collector, general transportation vehicle. If the only vehicle you have is the collector vehicle, you may still display collector plates on the motor vehicle, however you won't qualify for the reduced collector insurance premium. In addition, the modified collector motor vehicle must be rated for pleasure use only, and must not at any time be used for driving to or from, or part way to or from, work or school or for any business use.

STEP 5 — Vehicle Photographs

Applications submitted that do not meet all the listed photograph requirements will be rejected. Photos will not be returned. Every new application will require new photos.

You will be required to provide additional close up photographs if the photographs you submit do not provide clear detail of the vehicle's condition. Please visit the collector vehicles webpage at icbc.com for examples of good quality photographs.

PROVIDE DATE PHOTOS WERE TAKEN (must be taken within 90 days of application):

All images MUST be:

- taken within 90 days of mailing your application;
- · clear and detailed:
- of the current vehicle condition and equipment;
- in colour:
- · taken when the vehicle is clean and dry;
- high resolution and unaltered;
- taken in a well-lit area (no shade/shadows):
- a minimum size of 4" x 6";
- taken straight on, and not on an angle;
- · printed on glossy photo paper.

Interior

- entire dashboard (including radio and steering area)
- all interior door panels
- all seats (non-factory seat covers
- all floor areas (loose floor mats removed)
- headliner (not convertible)

STEP 6 — Personal Information

If your application is approved, a plate will be sent to the broker noted below. If the plate is not issued within 90 days, the broker will return the plate to ICBC.

STEP 7 — Statement of Applicant

For Licensing Purposes:

I declare that:

- a) I am a resident of British Columbia;
- b) the motor vehicle described above is in, and will remain in, a condition that makes it of significant value to a collector of motor vehicles by adhering to the requirements provided in step 3 Vehicle Condition Requirements;
- c) the attached colour photos are of the modified vehicle and accurately show the current condition of the vehicle;
- d) when licensed as a modified collector motor vehicle, it will be used solely for pleasure purposes and will not at any time be used for driving to or from, or part way to or from, work or school or for any business use;
- the modified collector motor vehicle:
 - i. is registered in British Columbia as a 1974 or earlier model;
 - ii. has the original vehicle manufacturer's body, coach or cab;
 - iii. the suspension, frame, drivetrain, engine, steering, brakes, body panels, and/or fuel type have been modified from the original manufacturer's specifications.

For Insurance Purposes:

I declare that when the motor vehicle described above is licensed and insured as a collector vehicle at the reduced collector motor vehicle premiums:

- a) it will be used solely for pleasure purposes and not for driving to or from, or part way to or from, work or school or for any business use, and
- b) I own or lease another licensed non-collector motor vehicle or motorcycle, or have a licensed non-collector motor vehicle or motorcycle as a company assigned vehicle that is insured for general transportation purposes in one of the following rate classes 001, 002, 003, 004, 005, 007, 011, 012, 013, 014, 015, 017, 021, 022, 023, 024, 027, 310 to 314, or 320 to 324.
- c) I will maintain the vehicle in the condition that makes it of significant value to a collector or exhibitor of motor vehicles regardless of age at all times during the original and each subsequent licence/insurance policy term.

WARNING - INSURANCE COVERAGE AND CONTINUED ELIGIBILITY IN THE MODIFIED COLLECTOR VEHICLE PROGRAM

Insurance coverage may be forfeited if the vehicle described above is used contrary to the statements made above under "For Insurance Purposes." If these conditions are not met, I understand that the vehicle will not be eliqible as a modified collector vehicle and the collector vehicle insurance rate class and that I must immediately contact an Autoplan broker to obtain appropriate licensing and insurance for my vehicle.

I acknowledge that if the vehicle is used for more than pleasure purposes at any time, after the initial application and approval as a Modified Collector vehicle, the vehicle is no longer considered to be eligible for the Collector Vehicle Program.

Where the applicant gives false particulars to the prejudice of the corporation or knowingly misrepresents or fails to disclose in this application any fact required to be stated herein, or uses the motor vehicle contrary to the statement made above, insurance coverage may be forfeited. ICBC reserves the right to apply additional qualifying criteria when determining a vehicle's Modified Collector Vehicle eligibility in accordance with the Motor Vehicle Act Regulations.
