

# Application to Register an Aquaculture Compensation Declaration

Section 186ZHA of the Fisheries Act 1996 provides for the lodgement of a Compensation Declaration if the Director-General of the Ministry for Primary Industries has made a reservation in relation to commercial fishing, or has deferred making a decision on a marine farming or spat catching permit application under the Aquaculture Reform (Repeals and Transitional Provisions) Act 2004, and compensation has been paid to quota owners for the stocks that the reservation or deferred decision relates to. Quota holdings of quota owners will be taken as at 5pm on the date on which the Director-General gives notice of the reservation or deferred decision.
