Caveat Amount

General Notes

Both the ACE owner and the Caveator are required to sign this form.

You may only caveat ACE where the owner holds sufficient ACE for the stock. You are unable to caveat ACE that is already subject to a caveat.

The ACE owner and the Caveator will be notified of the outcome of this application.

This caveat application is not effective until successfully registered.

A successful application for registration will be registered pursuant to section 159 of the Fisheries Act 1996.

This application must be accompanied by the prescribed fee.

The fee for this application can be determined by referring to the Schedule of Fees available from Fishserve.

This fee is inclusive of GST.

Fishing Year

A separate application form is required to caveat ACE for stocks with different fishing years.

ACE may only be caveated for the following periods:

- The current fishing year for a stock; or
- The previous fishing year for a stock. Such as an application must be received and registered by Fishserve by the 15th day after the end of that fishing year, and will only have effect until the end of that 15th day.

Effect of a Caveat

A caveat over ACE prevents the transfer of the amount of ACE caveated.

A caveat over ACE does not prevent reported catch being compared against caveated ACE for balancing purposes.

For the owner to be able to transfer caveated ACE, the Caveator must first withdraw the caveat, either in whole or in part.

A Caveator may withdraw a caveat in whole or part at any time before the 15th day after the end of a fishing year.

Privacy Act 2020 – Collection of Personal Information

Your personal information is being collected to enable your application to register a caveat over Annual Catch Entitlement (ACE) to be processed.

The agency collecting and holding this information is Commercial Fisheries Services Limited (Fishserve), PO Box 297, Wellington, 6140.

The collection of this information is required under section 149 of the Fisheries Act 1996. It is not mandatory that you supply this information, but your application may not be processed if you do not provide all the information requested on this form.

You have the right to access and correct your personal information.

You may apply to Fishserve to prevent the display of your personal address on registers kept under the Fisheries Act 1996 if you consider that disclosure would be prejudicial to your personal safety or to the safety of your family.
