Thank you for providing an opportunity for WSA to provide comment in relation to this amended Development Application – apologies for the slight delay in getting our comments back to you.

We have reviewed the documentation and provide the following commentary:

- Wildlife Hazard Risk Page 36 of the revised report in relation to wildlife hazard risk notes that "A wildlife management assessment report has been previously prepared, and its findings remain applicable to the amended proposal". This report doesn't appear to be on the Major Projects Portal, and WSA requests the opportunity to review this report. The most recent landscape design includes a number of high risk species (e.g. various Eucalyptus) as well as a detention basin, and has the potential to attract wildlife. Please confirm if the proposed species have been assessed from a wildlife hazard risk perspective, or are aligned with the species listed as part of the Western Sydney Aerotropolis Phase 2 Development Control Plan species list.
- **OLS Protected Airspace -** We request that a condition be included in relation to any future consent for this application to the effect of the below:

It should be noted that the Airports Act 1996 covers any intrusions into prescribed airspace, which could include:

- constructing permanent structures, such as buildings, into the protected airspace;
- temporary structures such as cranes, or event related structures protruding into the protected airspace; or
- activities causing non-structural intrusions into the protected airspace such as air

turbulence from stacks or vents, smoke, dust, steam or other gases or particulate matter.

If it is likely that any of the above components would result in an impact on protected airspace, then approval will need to be obtained in accordance with the Airports Act 1996 and the Airports (Protection of Airspace) Regulations 1996.

- **Waste Management** The submitted waste management plan should have consideration for wildlife attraction in relation to storage of waste (e.g. secure closing of bins, indoor storage of waste, etc). These measures may need to be conditioned as part of any future approval.
- Aircraft Noise We note that our previous comments stand in relation to the site being located within the 20-25 and 25-30 ANEC contours and therefore need to be designed in accordance with the relevant Australian Standards (including AS 2021-2015 Acoustics Aircraft noise intrusion Building siting and construction).

We are more than happy to discuss any of the above further as required.
