

## TULARE COUNTY FEDERAL CREDIT UNION 80<sup>TH</sup> MEMBER APPRECIATION SWEEPSTAKES OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- **1. ELIGIBILITY:** This 80th Anniversary Member Appreciation Sweepstakes is open only to legal residents of California, who are 18 years of age or older and a member of Tulare County Federal Credit Union Credit Union on or before April 30, 2019 and maintain a minimum of a \$25 share balance. You need not be present to win. Employees or Volunteers (and their immediate families or those living in the same household) of Tulare County Federal Credit Union Credit Union ("Sponsor") are not eligible to enter or win.
- 2. HOW TO ENTER: This 80th Anniversary Member Appreciation Sweepstakes begins at 8:00 a.m. PST on April 1, 2019 and ends at 5:00 p.m. PST on April 30, 2019. You may enter this 80th Anniversary Member Appreciation Sweepstakes via tularefcu.org/80years only. You may enter only once per person. Multiple entries received from any person per platform beyond this limit will void all such additional entries. All entries must be received by 5:00 p.m. PST on April 30th, 2019. Entries generated by a script, macro, or other automated means or by any means that subvert the entry process or interfere with fair play of this 80th Anniversary Member Appreciation Sweepstakes will be disqualified. Entries that are late, incomplete, incorrect, garbled, corrupted, or unintelligible for any reason, including, without limitation, computer or network malfunction or congestion, are void and will not be accepted. Mail-in entries must be postmarked by April 24, 2019 12:00pm noon PST and in-hand at the TCFCU Tulare offices (334 N K St., Tulare, CA 93274) by April 30, 2019 by 12:00PM PST. If an entry form is drawn, but judges are unable to determine the winner because of illegible writing, that entry form will be disqualified. No copies, mechanical reproductions, or metered mail accepted. Proof of mailing does not constitute proof of delivery. The Credit Union is not responsible for lost, late, incomplete, misdirected, damaged, postage-due, or illegible entries or mail. Mechanically reproduced entries will not be accepted. - **4. PRIZES AND APPROXIMATE RETAIL VALUE:** There will be a total of one (1) \$800 prize awarded via Cashier's Check. If a winner is unable to take possession of a prize, the prize will be forfeited without any

compensation to the winner.
