



## TULARE COUNTY FEDERAL CREDIT UNION 80<sup>TH</sup> ANNIVERSARY SOCIAL MEDIA GIVEAWAY OFFICIAL RULES

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY.**

**A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. ELIGIBILITY:** This 80th Anniversary Social Media Giveaway is open only to legal residents of California, who are 18 years of age or older on or before April 30, 2019. You need not be present to win. Employees, Volunteers (and their immediate families or those living in the same household) of Tulare County Federal Credit Union Credit Union ("Sponsor") are not eligible to enter or win.

**2. HOW TO ENTER:** 80th Anniversary Social Media Giveaways begins at 8:00 a.m. PST on April 1, 2019 and ends at 5:00 p.m. PST on April 30, 2019. Multiple entries received from any person per platform beyond this limit will void all such additional entries. All entries must be received by 3:00 p.m. PST on the day of each drawing. Entries generated by a script, macro, or other automated means or by any means that subvert the entry process or interfere with fair play of this 80th Anniversary Social Media Giveaway will be disqualified. Entries that are late, incomplete, incorrect, garbled, corrupted, or unintelligible for any reason, including, without limitation, computer or network malfunction or congestion, are void and will not be accepted.
