The applicant is permanently resident in Greater Manchester and is an ex-serviceman/woman with serious walking difficulties as a result of losing a leg in active service (known to British Limbless Ex-Servicemen Association).

#### Concessionary travel for service personnel and veterans

Proof of your disability can be provided as shown above or you may be automatically eligible if you have been awarded a lump sum payment under tariff levels 1-8 of the Armed Forces Compensation Scheme (AFCS) and have a letter from the Service Personnel & Veterans Agency (SPVA) proving receipt of one of the above.
