Registering to use your mobility scooter on Metrolink trams

The scheme is open to people who have an England National Concessionary Travel Scheme (ENCTS) Disabled Person's Pass, and do not have a condition that would prevent the safe operation of a mobility scooter on the Metrolink network. Your TfGM Travel Vouchers pass can also be used to prove eligibility.

Mobility scooter

The scope of this permit scheme is for mobility scooters. All manual and powered wheelchairs meeting the referenced criteria are already permitted on Metrolink, as are mobility scooters that are folded and fully encased.

To be eligible the mobility scooter must fit dimensions of:

- 600mm wide;
- 1000mm long;
- turning radius not exceeding 1200mm; and
- maximum combined (mobility scooter and user) weight of 300kg.

Mobility scooters not meeting these dimensions can be assessed on an individual basis.

Mobility scooters must have brake release/free wheel operations – to enable safe egress off the tram if the scooter breaks down, and is not battery powered only.
