




























Floor Plan



Electrical Plan One-Line




Metro & Long Haul Fiber









International Subsea Cable

The Market



Columbia, Maryland is part of the Baltimore/Annapolis metropolitan market and centrally located between Baltimore and the Northern Virginia data center markets. The area surrounding Columbia boasts a broad list of companies including significant research and development firms, technology companies, federal government and associated vendors, healthcare, financial services and education.

The Maryland Legislature and Governor Moore recently enacted the Critical Infrastructure Streamlining Act of 2024 which is another significant step in the support of new data center projects in the state.

The data center is located located 15 miles from Baltimore/Washington Airport and 18 miles southwest of the Baltimore CBD offering substantial low-latency fiber connectivity to numerous network providers and connectivity to the downtown Baltimore Carrier Hotel and the Northern Virginia market. The data center is approximately 55 miles from Northern Virginia

The regional area houses over 170 data centers with nearby Northern Virginia being home to the largest cluster of data center and cloud deployments in the US handling over 60% of the world's internet traffic.

Tax Incentives



The State of Maryland offers a Sales and Use Tax Exemption Incentive Program for data centers that locate or expand in Maryland.

A data center business can be eligible for a 10 year consecutive benefit period for companies that create at least five (5) qualified employment positions and invest at least \$2M in qualified data center personal property in Tier 1 areas and invest at least \$5M in any other area of the State.
