## DISCLOSURE ON EXPENSES RELATED TO LOBBYING ACTIVITIES AND MEMBERSHIPS FOR THE YEAR 2022

When undertaken with integrity and transparency, lobbying is a legitimate activity to engage in as part of the deliberate process of law making. Ageas's intention is to report on its lobbying activities and the expenses related to it. This disclosure includes the total amount spent on memberships and on lobbying Group-wide on an annual basis, as well as the 3 membership organisations receiving the largest contributions. The following overview includes amounts spent on lobbying practices, and membership fees to national and international organisations endorsed by Ageas SA/NV through its consolidated entities. These memberships can include trade associations, industry associations and business associations who, in certain cases, influence governments' or institutions' policies and decisions on behalf of its members.

In total the contributions to these three companies represent 63,7 % of the total amount of memberships paid or EUR 2,400,293.
