Moreover, the reader can choose between the "At first glance" summary review and the more in-depth "Detailed overview" of Ageas's annual results.

Lightly animated versions of the Annual Reports' graphs, histograms and pie charts are also available on the website. The visitor can choose which data set he or she wants to view with a simple click, adding or subtracting information from the graphics in an instant.

At the top of each page on the website, the "Add to my PDF" icon allows visitors to create a personalised and easily printable version of the chosen content. And finally, a PDF of the Annual Report can be downloaded, with the added benefit of being able to choose exactly which chapters to print—or not to print—via a simple interface.
