What is the overall deductible?	Tier 1: Individual \$2,000 / Family \$4,000. Tier 2: Individual \$4,000 / Family \$8,000.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay.
