Over time, this will also support inline commenting, enabling closer collaboration between reviewers, authors and editors, and a more efficient review process. 

Authors submitting to the pilot journals using our new submission experience have rated their user experience as exceptionally high (~90% "ease of use" and "meets my needs") in feedback surveys. We are, therefore, confidently adding more journals starting from September. Your Publisher will be in touch with you when your journal is able to benefit from the new submission experience.
