Dear Sir,

- I have been appointed as a Scrutinizer vide Resolution passed by the Board of Directors of Gillette India Limited ("the Company") on 30th October, 2014 for conducting the Postal Ballot process in connection with the above referred matter.
- I submit my report as under:
 - 2.1 The Company completed the despatch of Notice of Postal Ballot along with the Postal Ballot Forms and self addressed stamped envelopes through Speed/Registered Post on 12th February, 2015 through Registrar and Share Transfer Agent i.e. M/s. MAS Services Limited to the Members and the same were also sent by Email to the members by National Securities Depository Limited on 12th February, 2015, whose names appeared on the Register of Members/List of Beneficiaries as on 6th February, 2015.
 - 2.2 The Sealed Postal Ballot Forms received from the members were kept under the safe custody of the Registrar and Share Transfer Agent I.e. M/s. MAS Services Limited at T-34, 2nd Floor, Okhla Industrial Area, Phase II, New Delhi 110 020.
 - 2.3 All Postal Ballot Forms, received up to the close of working hours (1700 hours) on 14th March, 2015, the last date and time fixed by the Company for receipt of the Postal Ballot Forms were considered for my scrutiny.
 - 2.4 Envelopes containing Postal Ballot Forms received after 1700 hours on 14th March, 2015 were not considered for my scrutiny. These envelopes were not opened.
 - 2.5 The Postal Ballot envelopes were opened from 12th March, 2015 and the last lot was opened on 14th March, 2015 after 1700 hours in the presence of my authorized representatives.

2.6 Particulars of all the Postal Ballot Forms received from the members and the votes cast by electronic mode have been entered in a Register separately maintained for the purpose in ectronic mode.

- 2.8 I have not found any defaced/mutilated Postal Ballot Form.
- 2.9 I have also received a complete record of votes cast by electronic mode from National Securities Depository Limited, (Agency) for providing and supervising electronic platform on 14th March, 2015 which was closed by NSDL on 14th March, 2015 at 1700 hours.
