Dear Sir,

- I have been appointed as a Scrutinizer by the Board of Directors of Gillette India Limited ("the Company") for conducting the Postal Ballot process in connection with the above referred matter.
- 2. I submit my report as under:
 - 2.1 The Company completed the despatch of Notice of Postal Ballot along with the Postal Ballot Forms and self addressed stamped envelopes through Courier on 24th December, 2016 through Registrar and Share Transfer Agent i.e. M/s. MAS Services Limited to the Members and the same were also sent by Email to the members by National Securities Depository Limited on 24th December, 2016, whose names appeared on the Register of Members/List of Beneficiaries as on 16th December, 2016.
 - 2.2 The Sealed Postal Ballot Forms received from the members were kept under the safe custody of the Registrar and Share Transfer Agent i.e. M/s. MAS Services Limited at T-34, 2nd Floor, Okhla Industrial Area, Phase II, New Delhi 110 020.
 - 2.3 All Postal Ballot Forms, received up to the close of working hours (17:00 hours) on 23rd January, 2017 the last date and time fixed by the Company for receipt of the Postal Ballot Forms were considered for my scrutiny.
 - 2.4 Envelopes containing Postal Ballot Forms received after 17:00 hours on 23rd January, 2017 were not considered for my scrutiny. These envelopes were not opened.
 - 2.5 The Postal Ballot envelopes were opened on 23rd January, 2017 and the last fot was opened on 23rd January, 2017 after 17:00 hours in the presence of my authorized representative.
 - 2.6 Particulars of all the Postal Ballot Forms received from the members and the votes cast by electronic mode have been entered in a Register separately maintained for the purpose in electronic mode.

2.7 Envelopes containing Postal Ballot Forms, which were returned undelivered, were also not opened.
