# EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

Mr. Madhusudan Gopalan is an alumnus of IIM Calcutta, who joined Procter & Gamble in the sales function straight from campus in 1999. He has more than 18 years of experience working for Procter & Gamble across business units and diverse geographies like India, US and ASEAN countries. Prior to this role, Mr. Madhusudan Gopalan was leading the Procter & Gamble business in Indonesia, where he led strong sales growth, share turn around, strong value creation and cash productivity.

The Board, at its meeting held on May 11, 2018, upon the recommendation of the Nomination & Remuneration Committee, appointed Mr. Madhusudan Gopalan (DIN 08158357) as an Additional Director and Managing Director of the Company for a period of 5 (five) years with effect from July 1, 2018, subject to the approval of the shareholders and of the Central Government.

Mr. Madhusudan Gopalan has also been appointed as Managing Director of Gillette India Limited effective July 1, 2018, subject to requisite approvals. The Board of Directors have provided unanimous consent for the appointment of Mr. Madhusudan Gopalan as the Managing Director of Gillette India Limited, at aremuneration that shall be shared by the Companies in proportion of their Net Outside Sales (NOS).
