 - 2.3 All Postal Ballot Forms, received up to 5.00 p.m on January 24, 2019, the last date and time fixed by the Company for receipt of the Postal Ballot Forms and e-voting were considered for my scrutiny.
 - 2.4 Envelopes containing Postal Ballot Forms received after 5.00 p.m on January 24, 2019 were not considered for my scrutiny. These envelopes were not opened.
 - 2.5 The Postal Ballot envelopes were opened on January 24, 2019 in the presence of my authorized representative.
 - 2.6 I have not found any mutilated Postal Ballot Forms.
