Sub: Re-appointment of Mr. Krishnamurthy Iyer as Independent Director of the Company, for a period of five years, with effect from December 1, 2025

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that the Board of Directors of the Company, at its meeting held today, pursuant to recommendation of the Nomination & Remuneration Committee of the Company, have approved re-appointment of Mr. Krishnamurthy Iyer as Independent Director of the Company, for a period of five years, with effect from December 1, 2025, subject to the approval of the shareholders of the Company at the ensuing annual general meeting.

Further, we confirm basis declarations received that Mr. Krishnamurthy Iyer meets the criteria of independence laid down in Section 149 of the Companies Act, 2013 and SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015 and that he is not debarred or disqualified from holding the office of a Director by virtue of any order from SEBI/MCA or any such statutory authority. Mr. Krishnamurthy Iyer does not hold any shares in the Company. Further, as affirmed by him, he is not disqualified from holding the office of a Director pursuant to the provisions of Section 164 of the Companies Act, 2013.
