Jon Moeller has been an integral part of P&G's leadership team for well over two decades, developing strategies in support of P&G's long-term balanced growth and value creation objectives. As the company's Chief Operating Officer, he has profit/loss responsibility for P&G's Enterprise Markets (Latin America, India, Middle East, Africa, Southeast Asia and Eastern Europe). He also leads the company's Investor Relations, Information Technology, Global Business Services, Sales, Market Operations, Purchasing, Manufacturing, and Distribution efforts.

Jon held the role of P&G's Chief Financial Officer for more than 12 years, leading P&G's Finance & Accounting, Tax, Treasury, Corporate Strategy, Business Development and Investor Relations functions. He managed P&G's global Duracell, Salon Professional, Retail Hair Color, Prestige Fragrances and Retail Hair Color businesses for a multi-year period as those businesses were carved out for sale. Since joining P&G in 1988 as a cost analyst, Jon has held various senior leadership roles in categories, sectors and regions, including stints in China, as the company's Treasurer, Global Beauty, Health, Feminine Care Finance VP, and Corporate Forecasting & Analysis. He has led major merger and acquisition operations, including the Merck KGaA acquisition and the divestitures of P&G's coffee, snacks, pharmaceuticals, battery and prestige beauty businesses.

Jon sits on a number of business and industry advisory boards. He served on the Board of Directors for Monsanto for eight years and was Chairman of that Board's Audit Committee. He is active in business, civic and cultural issues of Greater Cincinnati, serving in an advisory role on local Boards and previously as President and then Chairman of the Cincinnati Art Museum Board of Trustees.
