








Presidential Election Result



Trump won both the popular vote and the electoral college (312 to 226).



Note: Maine gives two electoral votes to the candidate who wins statewide, and one to the winner of each of its two congressional districts. Nebraska gives two electoral votes to the candidate who wins statewide, and one to the winner of each of its three congressional districts.

- Federal Communications Commission (FCC) Chairman: Brendan Carr


*NOTE: These all require Senate confirmation/approval – with the EXCEPTION of the FCC because Carr is currently a sitting FCC commissioner and thus no Senate approval is needed to confirm (the President can elevate any commissioner to Chair)

Other Key Administration Picks

- White House Chief of Staff: Susie Wiles
- Deputy Chief of Staff for Policy: Stephen Miller
- Department of Government Efficiency (DOGE): Elon Musk and Vivek Ramaswamy
 - Not actually a "Department", and unclear what ability to create & effectuate actual policy DOGE would have
 - Trump has said it "will provide advice and guidance from outside of Government, and will partner with the White House and Office of Management & Budget to drive large scale structural reform."








Exploring committee leadership in the next House of Representatives.

FY 2025 Appropriations Update

- Congress has until **Friday, Dec. 20, 2024,** to pass a government funding deal.
- We'll be watching to see if the President-elect encourages lawmakers to wrap up spending by the end of this year, giving the next administration more floor time to dedicate toward GOP budget reconciliation priorities.
- Lawmakers could also pass another short-term CR into next year to give the new administration and the 119th Congress more leeway over future spending levels.





Trump 2.0 Legislative Agenda

- With a GOP-controlled Congress, Trump's legislative priorities are more likely to be taken up/considered
- Possible priorities include:
 - Repeal of wide-range of Biden administration regulations
 - Tax legislation to build on and codify the Tax Cuts and Jobs Act (TCJA) of 2017
 - Merger-friendly Antitrust policy
 - Sixty (60) percent tariff on all Chinese goods
 - Changes to the Affordable Care Act (ACA)
 - Specifically regarding expiring subsidies, Medicaid changes
 - Biden landmark law changes/repeal effort (IRA & CHIPS)

Trump Impact on Rules

- What we expect in the near-term only the regulations required by statute will be released by the Biden administration (e.g., Part D annual rule)
- Other rules pending review at the White House's Office of Management & Budget (OMB) – including the Office for Civil Rights' (OCR) "Proposed Modifications to the HIPAA Security Rule to Strengthen the Cybersecurity of Electronic Protected Health Information" – are unlikely to be released
- Other rulemaking required by law that is somewhere in the process of being written notably the CIRCIA final rule which is slated for a release in fall of 2025, gives the new administration plenty of time to revise/rewrite (if they want to)
- Repeal efforts on other Biden administration regulations

The Congressional Review Act (CRA)


- Use of the Congressional Review Act
 - What is it? A tool Congress can use to overturn certain federal agency regulations & actions
 - Issued in the final 60 legislative business days of this Congress ("lookback" window); essentially assures the next Congress has a full 60 days to use the CRA
 - Unknown: what the lookback window date will be (Aug. 1?)
 - The CRA <u>has been used</u> to overturn a total of 20 rules: one in the 107th Congress (2001-2002), 16 in the 115th Congress; (2017-2018), and three in the 117th Congress (2021-2022)
 - Trump 1.0 (2017) was historic for the CRA, 67 Resolutions of Disapproval (RDs) were introduced, and 16 were signed into law
 - Over 200 attempts to use CRA, which are sometimes messaging tools and meant to influence agency action

CRA Lookback

The Spring 2024 Unified Agenda presents 3,698 rules at various stages of production from over 60 federal departments, agencies and commissions.

So – even an unprecedented overturning of 16 rules is really a drop in the bucket.

Trump 2.0 – Deregulation 2.0?

- During Trump's first presidency, he signed an Executive Order (EO) that would require agencies to revoke two regulations for every new rule they want to issue
 - "Patients Over Paperwork" at CMS
- There are other tools in Trump's toolbox to revise existing rulemaking
 - There are several options & combinations of these tools to reverse Biden-era rules including withdrawals, regulatory suspensions, strategic responses to litigation, issuing revised rules through the notice-and-comment process (lengthy, but an option), and other executive actions including EOs
 - Additionally, incoming presidents typically issue a "regulatory freeze" on day one of their administration
- Has pledged to overturn President Biden's sweeping EO on AI (issued Oct. 2023) on his first day in office
 - President has the power to revoke an EO issued by a predecessor and will certainly issue new EOs
- Efforts to dismantle/invalidate other Biden administration regulations, policies, and guidance documents are expected
