## History of Certification Programs

Established in 1992, the College of Healthcare Information Management Executives (CHIME) was created out of a need to bring education and resources to healthcare Chief Information Officers. Since the beginning, CHIME has expanded its reach to nearly all healthcare professionals serving in healthcare technology, security, and more. In 2009, CHIME launched the first CHIME exclusive certification for healthcare CIOs., the Certified Healthcare CIO (CHCIO). It was created by healthcare CIOs to test the skills and experience of healthcare IT executives and recognize them for their expert knowledge and leadership in this area.

With the growing success of the CHCIO program, CHIME expanded its borders to develop a similar certification program for CHIME international members in 2016. One year later, a new designation, the CHIME Foundation Certified Healthcare Executive (CFCHE), was born. This developed as a result of the expressed desire within the CHIME Foundation partners who deliver products and services to provider members. From there, CHIME certifications continued to expand globally (German CHCIO Program in 2019 and UK CHCIO Program in 2020) as well as skill-based (Certified Healthcare Information Security Leaders, CHISL).

As CHIMEU launched to provide exceptional educational opportunities to all healthcare professionals beyond CHIME membership, providing a metric of success through certification was critical. The Certified Digital Health (CDH) Program not only allows all types of healthcare professionals to become certified in digital health but is uniquely crafted to grow with the professional throughout their career through three levels (professional, leader, and executive).

- □ Complete 10 qualifying continuing education units (CEUs)

## **Certification Maintenance**

#### **Initial Certification:**

- Application Complete
- Pass Examination
- 10 CEUs (earned within 12 months prior to enrollment date to current date)
- Enrollment fee

#### **Certification Renewal:**

- 45 CEUs every 3 years
- Minimum of half (22.5) coming from CHIMEU education
- Renewal fee
