### **Government Funding Situation**

- Government funding was set to expire at midnight on September 30th
- Lawmakers pulled out a surprise last-minute deal to keep the government open just hours before the deadline
- Federal agencies, including HHS, had started to send out contingency staffing plans for operations in the absence of funding
- What passed?
  - <u>H.R. 5680</u> bill text
  - A 45-day continuing resolution (also referred to as a "CR"). New funding deadline is Nov. 17th
  - Included \$16 billion in supplemental disaster relief and other extensions
  - Did NOT include additional military and economic assistance for Ukraine



## Speaker

- As a result of putting that bill on the floor, Rep. Matt Gaetz (R-FL) filed a motion to force a vote on ousting the speaker
- How did this happen?
  - One-Member Motion-to-Vacate policy
- With a 9-seat majority, McCarthy could only lose 5 GOP votes.
- Ultimately, McCarthy was unable to negotiate with Democrats or the handful of Republicans (8) who opposed him, to save his job
- The final vote was 216-210 in favor of removing him
- Currently there is an interim speaker: Rep. Patrick McHenry (R-NC)

### **Speaker Election**

- 217\* votes are needed to win the gavel
- The two candidates that have publicly announced that they are running for the position are Majority Leader Steve Scalise (R-LA) and Judiciary Committee Chair Jim Jordan (R-OH)
- At least one member has thrown out former President Trump's name



- It's unclear whether Leader Scalise or Chair Jordan have the votes needed to win the gavel
- This has fueled speculation about a potential Kevin McCarthy comeback bid.

#### Speaker Election—Schedule

- Monday: GOP Conference met in what has been described as a "therapy session" that was "mostly civil"
- Tuesday: House Republicans met again yesterday for a more formal candidate forum to hear directly from Majority Leader Steve Scalise (R-LA) and Judiciary Committee Chair Jim Jordan (R-OH), each of whom will make their case as to why they should wield the speaker's gavel
- Wednesday: The tentative plan is to hold the vote on the floor today. However, according to reports, an internal GOP election for speaker will be held today ahead of any votes on the floor. The meeting started around 10 am ET. The latest is that there was an effort to increase the vote threshold to bring a candidate to the floor, but that effort failed.

Why is electing a speaker so important? Several reasons!



#### Shutdown Impact on Federal Agencies

- Agencies will begin to put out contingency plans outlining agency operations in the event of a federal government shutdown (i.e., a lapse in appropriations)
  - Example: HHS FY24 Contingency Plan
  - What does this mean?
- Rules and rulemaking process could be impacted/delayed

#### Administration AI Efforts Ongoing

The WH's Office of Management and Budget (OMB) will soon release draft policy guidance for federal agencies to ensure the development, procurement, and use of AI systems is centered around safeguarding American's rights and safety – may be in form of Request for Information (RFI)
New E.O. on AI rumored to be released...potentially as soon as this week
