The following terms and conditions (the “Terms”) apply to you if you’re the registered owner of a car with built-in transponder capabilities or a transponder-equipped vehicle (“TEV”). TEVs are designed by your vehicle’s manufacturer to work on Highway 407 ETR and/or the Province of Ontario’s toll highways (collectively, the “Toll Highways”). Please consult with your local dealership or your vehicle’s manufacturer if you have any questions or experience any issues with the TEV.

What you agree to when you sign this application

By using a TEV on the Toll Highways, you accept and agree to follow the Terms and any changes to them. We’ll let you know in advance if we change any of these Terms and you are deemed to agree to all changes when you next drive on the Toll Highways.

Paying tolls, fees and other charges

- You must pay all tolls, fees and other charges, incurred in connection with the TEV or travel on the Toll Highways. **If you don’t pay, we may charge interest and applicable fees, temporarily or permanently suspend the TEV, commence collection activities and/or legal proceedings, and you may not be able to renew your vehicle permit or get a new one.** If we temporarily suspend the TEV, we may reinstate it after receiving full payment. All Terms will remain in force while the TEV is temporarily suspended. All tolls, fees and other charges are set out in the Fee Schedule and the Complete Fee Details located at 407etr.com.
- Joint owners of a licence plate are both responsible (separately and together) for paying any amounts owed to us. We decide how to allocate your payments to the amounts you owe.
- If you get a bill that includes Camera Charges, call us within 30 days of the bill date to discuss them with us. If you don’t, you’re responsible for all applicable charges plus any interest.

How we use your information

- We may collect, use, disclose and retain information about you for the purposes described in our Privacy Policy and in accordance with Canada’s *Personal Information Protection and Electronic Documents Act* and Ontario’s *Freedom of Information and Protection of Privacy Act*, as applicable.
- We collect Toll Highway trip details using the TEV in order to bill you.
- In order to operate and manage the Toll Highways, we may contact you about your overdue balance, request a credit investigation or a consumer report about you, or exchange information about you with governmental agencies, credit reporting agencies, collection agencies, or other relevant service providers in Ontario or other jurisdictions. This information may also impact your application.** Please see our Privacy Policy at 407etr.com for more information.

Transferring ownership

- It is your responsibility to promptly notify 407 ETR of any changes to ownership of the vehicle described above, as well as any subsequent registration by you of another TEV.
- If there is a change to the vehicle’s ownership, you must pay in full all amounts you owe on your accounts. If you’re on pre-authorized payment, we may charge your credit card or debit your bank account until all amounts you owe us are paid.

Liability and Responsibility

- 407 ETR is not responsible for, and does not make any representations or warranties about, the maintenance, reliability, performance or operation of the TEV or the TEV’s functionality with the Toll Highways’ current or future tolling system technology.
- If the TEV stops working or you experience technical issues, please contact your local dealership or the vehicle’s manufacturer.
- 407 ETR is not liable for any direct, indirect, special, incidental, exemplary, punitive or consequential damages of any kind, or for any losses, claims, costs or expenses arising from your use of or reliance on the TEV including, and without limitation, any tolls, fees or other charges, such as Camera Charges, incurred as a result of the use, misuse, functioning or malfunctioning of the device.**
- If your vehicle is stolen, you must let us know immediately and provide a copy of a police report. You will be responsible for all tolls, fees and other charges related to any travel on the Toll Highways up to the time you report your vehicle stolen.

Application of Terms

- Certain Terms, such as those that help us to collect unpaid amounts, will still apply even if the vehicle’s ownership has changed.
- The laws of Ontario govern the Terms which are to be interpreted by the courts of Ontario.
