Journey starts from Denmark 自丹麦出发前往中国 Starting from 18 May 2022, all China-bound passengers from Denmark need to take two PCR tests instead of "PCR + IgM Antibody" tests. 自 2022 年 5 月 18 日起, 所有来自丹麦前往中国的旅客需进行两次核酸检测 (取代先前的核酸及血清抗体检测)。更多详细信息请参阅: http://www.chinaembassy.dk/lsfw/202201/t20220129_10636499.htm	Journey starts from a Schengen country or Non-Schengen Country outside Denmark 自丹麦以外的申根国或非申根国出发前往中国 Passengers transit at Copenhagen Airport to China must obtain a valid HS/HDC code issued by the Chinese Embassy or consulate before departing from the country of origin. If no HS/HDC code for the first leg will not be able to apply for the HS/HDC code for the second leg. 旅客经丹麦哥本哈根转机前往中国, 自始发国出发前须获得中国驻当地使领馆颁发的有效健康码。如无始发地健康码, 则无法申请第二程健康码。

<ul style="list-style-type: none">Test facilities Designated test facilities at Copenhagen Airport: PCR tests at Falck Medical center in Terminal 2 指定检测点位于哥本哈根机场 2 号航站楼安检区域前。	<ul style="list-style-type: none">Test facilities Designated test facilities at Copenhagen Airport: PCR tests at Falck Medical center in Gate C26. 指定检测点位于 C26 登机口旁。
<p>No specific requirements for journey starts from China to Denmark or transit at Copenhagen Airport. Entering into Shanghai Pudong Airport (PVG), 48 hours PCR test and 24 hours antigens test are required. 24 hours PCR only will also be accepted. From June 30, 2022, the quarantine time for entering Shanghai has been adjusted to 7+3 days.</p> <p>自中国前往丹麦或在哥本哈根机场转机目前无特殊要求. 进入上海浦东机场需要提供 48 小时内核酸检测阴性证明及 24 小时内抗原检测阴性证明。持有 24 小时内的核酸检测阴性证明亦可。自 2022 年 6 月 30 日起，入境上海隔离管控时间调整为 7+3 天。</p>
