- (1) Subject to subsection (5), where a local government wishes to set aside money for use for a purpose in a future financial year, it is to establish and maintain a reserve account for each such purpose.
- (2) Subject to subsection (3), before a local government
 - (a) changes* the purpose of a reserve account; or
 - (b) uses* the money in a reserve account for another purpose, it must give one month's local public notice of the proposed change of purpose or proposed use. * Absolute majority required.
- (3) A local government is not required to give local public notice under subsection (2) -
 - (a) where the change of purpose or of proposed use of money has been disclosed in the annual budget of the local government for that financial year; or
 - (b) in such other circumstances as are prescribed.

BACKGROUND

A local government is required to prepare a statement of financial activity reporting on the revenue and expenditure as set out in the annual budget for that month. The details in the statement are those as prescribed and the statement is to be reported to Council.

COMMENTS

Presented as an attachment this month, is the eighth monthly financial statement for the new financial year (presented in nature and type format) prepared from information posted in the OneCouncil system.

For the purposes of reporting other material variances from the Statement of Financial Activity, the following indicators, as resolved by Council, have been applied.

Revenue

Material variances are identified where, for the period being reported, the actual varies to the budget by an amount of (+) or (-) \$100,000 and in these instances an explanatory comment has been provided.

Expense

Material variances are identified where, for the period being reported, the actual varies to the budget by an amount of (+) or (-) \$100,000 and in these instances an explanatory comment has been provided.

For the purposes of explaining each Material Variance, a three part approach has been taken.

The parts are:

1. Period Variation

Relates specifically to the value of the Variance between the Budget and Actual figures for the period of the report.

2. Primary Reason

Explains the <u>primary</u> reasons for the period Variance. As the report is aimed at a higher level analysis, minor contributing factors are not reported.

3. Budget Impact


Forecasts the likely dollar impact on the Annual Budget position. It is important to note that figures in this part are 'indicative only' at the time of reporting, for circumstances may subsequently change.

At the 24 June 2024 Ordinary Meeting, Council adopted the Budget Variations Process Map which kept the Capital variation at \$50,000 and the Operating to Operating variation at \$100,000 to align with the overall adopted material variation threshold. Budget variations are presented to Council for authorisation by 'Absolute Majority' in circumstances where a forecast variation requires a movement from:

- Operating to Capital.
- Capital to Capital over \$50,000.
- Capital to Operating.
- Operating to Operating for amounts greater than 5% or \$100,000 (whichever is greater).



Budget Variation Process Map



The June 2024 decision of Council also permitted the Chief Executive Officer to amend a grant funded capital works budget, if there was a corresponding increase in the grant funding.

The Chief Executive Officer is authorised to approve amendments to capital budgets that are fully funded by external sources and that require an increase cost, commensurate with an increase in funding, but do not necessarily change scope. This caters for circumstances where Developer Contribution Works (which are pre-approved by Council) can be varied in terms of timing of delivery, if required.

DETAILS

Presented as an attachment is the Monthly Statement of Financial Activity for the ninth (9) month period ended 31 March 2025. The Monthly Statements are based on the model statements provided to the sector, which have been developed by Moore Australia, in conjunction with the Department of Local Government, Sport and Cultural Industries.

Capital Program Update

Included in the monthly report as an attachment is the list of the capital program as at the end for March 2025. Attachments are provided separately for projects above \$250K and projects under \$250K. At the end of March, actual spend plus commitments totalled \$20.1M.

Budget Variation Request: Brookton Highway Hill Street Intersection Upgrade

The City is currently delivering road intersection improvements at the intersection of Brookton Highway and Hill Street in Kelmscott to improve vehicular and pedestrian safety. These works include widening the existing intersection to facilitate safe turning movements from Brookton Highway and improving the pedestrian footpath.

The project is funded in part by a grant from the State Government.

Earlier this year, Council approved a budget variation in the mid review to reflect the market response to the call for tenders for the project. More recently, a number of latent conditions encountered at the site during construction such as asbestos pipes and clay subgrade as well as main roads changing their traffic management requirements to require night works, have further increased the cost of works. The project now requires an additional \$250,000 to complete.

Savings have been identified for transfer from the Civil Works operations budget. Projections for the Civil Works operational budget forecasts underspends in both material/contracts and labour cost. Council approval is required for this budget transfer, as funds will be transferred between the Civil Works operational budgets to the Capital Works budget for the Brookton Highway Hill Street Intersection Upgrade.

A further \$307K has been collected from debtors who are currently not on payment arrangements. \$4.3M has now been collected since July 1. Attention is also now occurring on the one year properties which are currently lagging in order to avoid them becoming two year statistics going forward.

Sundry Debtors

The total of Sundry Debtors 120+days has reduced slightly to \$0.83M. The breakdown for the 120 day plus category is:

- \$674K is with Fines Enforcement Registry for collection
- \$36K relate to Waste commercial customers which will be presented to Council for consideration in June
- A further \$47K relate to Planning and Building debtors, which should be collected
- A number of community organisations make up the balance.

In Brief:

- Each financial year Council is required to set a value for reporting material variances in monthly statements of financial activity.
- This report recommends that the values adopted by Council for the current 2024/25 financial year remain unchanged for the coming 2024/25 financial year except for an increase in the capital expenditure threshold from \$50,000 to \$100,000, ie:
 - Revenues Material variances will be identified, where the actual varies to budget by an amount of (+) or (-) \$100,000.
 - Expenses Material variances will be identified where the actual varies to budget by an amount of (+) or (-) \$100,000.
- This report also recommends that the reporting thresholds for budget variations be approved. These remain unchanged as to what was adopted in the current financial year with the exception of the capital threshold changing from \$50,000 to \$100,000.

 - (b) determine the local government's policies.
- 6.8. Expenditure from municipal fund not included in annual budget
- (1) A local government is not to incur expenditure from its municipal fund for an additional purpose except where the expenditure
 - (a) is incurred in a financial year before the adoption of the annual budget by the local government; or
 - (b) is authorised in advance by resolution*; or
 - (c) is authorised in advance by the mayor or president in an emergency.
 - * Absolute majority required.

The *Local Government (Financial Management) Regulations* 1996 – Regulation 34 Clause 5 – states:

Each financial year, a local government is to adopt a percentage or value, calculated in accordance with AAS (Australian Accounting Standards), to be used in statements of financial activity for reporting material variances.

AASB 1031 (Australian Accounting Standards Board) relates to the issue of materiality. Whilst there are a number of factors associated with materiality, the notion of materiality influences whether an item or an aggregate of items is required to be recognised, measured or disclosed in accordance with the requirements of an Australian Accounting Standard.

BACKGROUND

Each year Council is required to adopt a percentage or value for the purposes of reporting material variances in the (Monthly) Financial Activity Statement. This value or percentage is then used throughout the financial year to identify potential instances where actual revenues and expenditures may not be in keeping with Council's budget. The early identification of potential budget variances can assist in better utilisation and allocation of Council funds and resources.

For the current 2024/25 financial year, Council adopted the following material variance factors:

- i) Revenues Material variances will be identified where, for each Management Area, for the period being reported, the actual varies to budget by an amount of (+) or (-) \$100,000.
- ii) <u>Expenses</u> Material variances will be identified where, for each Management Area, for the period being reported, the actual varies to budget by an amount of (+) or (-) \$100,000.


The values chosen are believed to provide a good indication of variances to budget that require closer examination, and if necessary, remedial action. The values as proposed have worked well for the identification of potential variances in the past, and are, from a financial management perspective, felt to adequately serve the purpose for which they are resolved.

The Annual Budget is a financial estimate of expected revenues and expenditures and inevitably, variations do arise largely due to economic factors. During the year, budget variations may be necessary to reallocate budgets within services and manage the overall financial position, or to respond to changes in the economy. This is a critical financial management process that requires endorsement by the Council in the exercise of its duty under s2.27(2)(a) of the *Local Government Act 1995*.

The following budget variation process map is submitted to Council for endorsement. The circumstances in which a budget variation is submitted to Council is outlined in the process and a general threshold of \$100,000 is included which is the same as last year. The only change proposed is for Council to consider amending the current \$50,000 threshold for capital expenditure to \$100,000 so that all of the categories are at the same \$100,000 threshold for the next financial year.



Budget Variation Process Map



Variations will be presented to Council for authorisation by "Absolute Majority" in circumstances where a forecast variation requires a movement from:

- Operating Expense to Capital Expense or vice versa
- Capital to Capital where the variation is over \$100,000 (was \$50,000) but within the same capital works sub program
- Capital to Capital where funds are moved from one sub program to a different sub program
- Operating to Operating for amounts greater than 5% or \$100,000 (whichever is greater) or where any funds are moved to a different operating program and nature and type
- Capital programs where the scope of works has changed from that originally approved by Council.

The proposed budget variation process map facilitates budget management at the Council and officer level. Specific to capital works, where a capital to capital variation is requested, if the capital works job is within the same sub program (for instance road reseals), then the respective Director can amend the budget between capital jobs to accommodate variations for unforeseen circumstances, up to \$100,000 (was \$50,000).

The Chief Executive Officer is authorised to approve amendments to capital budgets that are fully funded by external sources and that require an increased cost, commensurate with an increase in funding, but do not necessarily change scope. This caters for circumstances where Developer Contribution Works (which are pre-approved by Council) can be varied in terms of timing of delivery, if required or when grant funding bodies such as Main Roads pay for increases in costs to approved projects.

COMMENT

Taking into account the commentary held in AASB 1031 (Materiality), the understood intent for which the material variances values are intended to serve and the successful use of these values from past financial years, it is proposed that the same values of \$100,000 be used again in the 2025/26 financial year and with the change proposed to the capital expenditure threshold then all of the categories will have the same threshold vale of \$100,000 applied.

For instances where Budget Variations are required to accommodate business and operational changes, the Budget Variation process with the proposed amended threshold amounts, will be applied.

RECOMMEND

That Council, pursuant to Regulation 34(5) of the *Local Government (Financial Management) Regulations 1996*, adopt the following values for reporting material variances and budget variations in the monthly Statements of Financial Activity during the 2025/26 financial year. There is no change recommended to the material variances threshold, a change of \$100,000 for the previously adopted \$50,000 threshold for Capital to Capital Budget Variations and no change to the \$100,000 threshold for Operating to Operating Budget Variations from the previous year, ie:

- 1. Revenues material variances will be identified where, for each Management Area, for the period being reported, the actual varies to budget by an amount of (+) or (-) \$100,000.
- 2. Expenses material variances will be identified where, for each Management Area, for the period being reported, the actual varies to budget by an amount of (+) or (-) \$100,000.

- 3. Authorise the Chief Executive Officer to vary the budget, except in the following circumstances, which require the proposed variations to be presented to Council for authorisation by "Absolute Majority":
 - Capital to Operating or vice versa
 - Capital to Capital, unless:
 - o the value is less than \$100,000 (was \$50,000) within the same sub program and does not extend the original scope of works approved; or
 - The increases to a capital budget is fully funded by external sources and is commensurate with an increase in funding, and does not necessarily change scope
 - Operating to Operating for amounts greater than 5% or \$100,000 (whichever is greater) or where funds are moved to a different program and nature and type
 - Where no budget is provided for an additional purpose (s6.8 of the *Local Government Act 1995*).

- Council resolved on 24 February 2025 to accept a cost estimate from the Western Australian Electoral Commission (WAEC) to conduct the City's 2025 election, pending written agreement being provided by the WAEC for the purpose.

BACKGROUND

Council resolved at its OCM on 24 February 2025 to accept a cost estimate provided by the WAEC to conduct the 2025 local government election for the City:

"Recommendation CS5/2/25 – 2025 Local Government Election – WAEC Cost Estimate

That Council:

- 1. Accept the cost estimate of \$340,353 from the Western Australian Electoral Commissioner dated 12 December 2024, to conduct the 2025 local government election for the City of Armadale, on the basis of the election to be conducted as a postal election pursuant to section 4.61(2) of the Local Government Act 1995.
- 2. Request the Chief Executive Officer to seek the written agreement of the Western Australian Electoral Commissioner to conduct the 2025 local government election, noting that a subsequent report to Council will be required to declare the Western Australian Electoral Commissioner responsible for the conduct of the election pursuant to section 4.20(4) of the Local Government Act 1995.

DETAILS OF PROPOSAL

Pursuant to Council's decision, the CEO implemented item (2) of the resolution above and has obtained an agreement document from the Commissioner of the WAEC for Council's endorsement, which is attached to this report.

Notwithstanding the WAEC's offer, the City has placed Council's concerns on record with the WAEC in terms of cost increases for each successive election, noting the differential between the estimates and the actual costs for the past 2 local government election cycles.

OPTIONS

Council could decide to conduct the election as an in person election.

This is not recommended, as it would likely reduce voter participation, as electors would need to travel to a polling place to cast their votes rather than at their convenience by way of a postal vote. Such a decision may also attract criticism from electors for this reason. Additionally, the City does not have sufficient capacity to resource the coordination and conduct of an in person election.

As it currently stands the *Local Government Act 1995* provides that the only entity permitted to conduct a postal election is the WAEC.

CONCLUSION

It is recommended Council accept the written agreement from the Commissioner of the WAEC. It is beneficial for the City to have the WAEC conduct the election, as it will be run independently and reduce administrative inputs for the City. As the only entity permitted to conduct an election by way of postal vote, conducting the election in this manner will result in greater voter engagement compared with in person voting.

Nevertheless given the concerns raised in respect of the 2023 local government election and the recent State election, City officers will be closely monitoring progression of the election period milestones to ensure any issues identified will be addressed promptly.

RECOMMEND

That Council:

- 1. Declare*, in accordance with section 4.20(4) of the *Local Government Act 1995*, the Electoral Commissioner to be responsible for the conduct of the 2025 ordinary election, together with any other elections or polls which may be required;
- 2. Decide*, in accordance with section 4.61(2) of the *Local Government Act 1995* that the method of conducting the election will be as a Postal election; and
- 3. Authorise the Chief Executive Officer perform any necessary administrative or liaison tasks with the Western Australian Electoral Commissioner in order to facilitate the delivery of the election.

BACKGROUND

On 6 December 2024, the *Local Government Amendment Act 2024* (Amendment Act) received Assent and came into effect the following day. As has been the practice of the State Government with the previous amending legislation to the *Local Government Act 1995* (LG Act), there are staged implementation dates for different parts and operative provisions of the legislation.

The Amendment Act introduced, by way of inserting a new Part 7 of Schedule 9.3 of the LG Act, a requirement for all local governments to essentially vacate the positions of presiding member and deputy presiding member of their committees on 1 July 2025, and reappointing council members to those positions in accordance with the new procedure prescribed in the LG Act.

This change does not affect the composition of an audit committee (City Audit). Reforms brought by the Amendment Act that affect audit committees are dealt with in a different way, requiring the Chair and Deputy Chair to be independent. These particular changes to audit committees will be the subject of a separate report to Council.

DETAILS OF PROPOSAL

In respect of a presiding member of a committee, clause 67(2) of Schedule 9.3 of the LG Act requires as follows:

(2) For each of its existing committees, a local government must make its first appointment of the presiding member under new section 5.12(1) no later than 1 July 2025.

A similar provision in clause 68(2) exists for the position of deputy presiding member of a committee:

(2) An existing deputy presiding member may continue to be the deputy presiding member of their committee until the end of 30 June 2025.

Whilst the Amendment Act and the LG Act are silent on the aspect of what will happen if the above is not done, it is expected that if the appointment is not performed in accordance with the LG Act, any ongoing arrangement that is not compliant with the legislation will mean an existing tenure of a presiding member or deputy becomes invalid.

The Amendment Act also amended section 5.12 of the LG Act in the following way:

5.12. Presiding members and deputies

- (1) The local government must appoint* a member of a committee to be the presiding member of the committee.
 - * Absolute majority required.
- (2) The local government may appoint* a member of a committee to be the deputy presiding member of the committee.
 - * Absolute majority required.

This contrasts with the pre-Amendment Act where the presiding member and deputy presiding member were <u>elected</u> by Council, and the election process was required to be conducted in accordance with the Schedules of the LG Act, using a preferential vote and count method:

5.12. Presiding members and deputies, election of

- (1) The members of a committee are to elect a presiding member from amongst themselves in accordance with Schedule 2.3, Division 1 as if the references in that Schedule
 - (a) to "office" were references to "office of presiding member"; and
 - (b) to "council" were references to "committee"; and
 - (c) to "councillors" were references to "committee members".

- (2) The members of a committee may elect a deputy presiding member from amongst themselves but any such election is to be in accordance with Schedule 2.3, Division 2 as if the references in that Schedule
 - (a) to "office" were references to "office of deputy presiding member"; and
 - (b) to "council" were references to "committee"; and
 - (c) to "councillors" were references to "committee members"; and
 - (d) to "mayor or president" were references to "presiding member".

It would appear the DLGSC has taken some note of the complaints raised by the sector since the introduction of the preferential voting method, by removing the need to conduct an internal election in this manner. This is welcome as it removes unnecessary complexity for local governments.

It should be noted, however, that a presiding member and deputy presiding member for a committee (from 1 July 2025) will then be an *appointment*, rather than being elected by Council.

The local government election this year is to be held on 18 October 2025. As is required by section 5.11(1)(d) of the LG Act, the offices of the City's committees are vacated on election day, with the first Council meeting after the election determining the council members appointed to all committees, and consequential appointment of a presiding member (Chair) and deputy presiding member (Deputy Chair).

This means that little over three (3) months will have passed since Council will have been required to appoint a Chair and Deputy Chair to each committee in accordance with the new requirements of the LG Act, for these positions to be vacated again on election day.

The above is considered to be inclusive of the City Audit Committee. A local government audit committee must be established in accordance with section 7.1A of the LG Act separately from a standing committee of Council.

With respect to audit committees, section 87 of the Amendment Act introduced new requirements in respect of appointment of an independent chair and deputy chair of an audit committee (to be called an Audit, Risk and Improvement Committee in the future). Section 87 of the Amendment Act is yet to be Proclaimed; the future commencement day is not known, however the Amendment Act specifies that the Audit, Risk and Improvement Committee is to be established no later than 6 months after the day section 87 commences. Accordingly as this is a future requirement, Council is not required to implement this particular change at this time.

It is recommended that, to ensure continuity of the committee leadership for the remaining three months before local government election day, the existing Chairs and Deputy Chairs be reappointed to all committees from 1 July 2025 to ensure compliance with the LG Act; and that those positions become vacant on election day as they otherwise normally would.

This also means there would be no call for nominations for council members who may be interested in contesting the position of Chair or Deputy Chair. All other committee positions would be unchanged by this approach (and are unaffected by the changes to the LG Act in any case) until election day.

OPTIONS

Council may opt to:

- 1. Use the method recommended by this report; or
- 2. Call for nominations from council members to contest appointment to Chair and/or Deputy Chair positions.

CONCLUSION

For the reasons outlined in this report it is not recommended to conduct any changes to the constitution of the City's committees, for what will be a short 3 month window before the committee Chairs and Deputy Chairs will be vacated in any case. This approach will ensure Council remains compliant with the LG Act and will avoid any unnecessary disruption to the Standing Committees in the lead up to the election period and the commencement of the new Financial Year.

RECOMMEND

That Council:

- 1. Effective from 1 July 2025 in accordance with section 5.12(1) and Schedule 9.3 cl. 67(2) of the *Local Government Act 1995*, appoint*:
 - a) Cr S J Mosey, as Chairperson of the Corporate Services Committee;
 - b) Dr C Wielinga, as Chairperson of the Development Services Committee;
 - c) Cr M Silver, as Chairperson of the Community Services Committee;
 - d) Cr K Busby, as Chairperson of the Technical Services Committee; and
 - e) Cr S Peter, as Chairperson of the City Audit Committee.
- 2. Effective from 1 July 2025 in accordance with section 5.12(2) of the Local *Government Act 1995*, appoint*:
 - a) Cr S Peter JP, as Deputy Chairperson of the Corporate Services Committee;
 - b) Cr M Silver, as Deputy Chairperson of the Development Services Committee;
 - c) Cr P Hetherington, as Deputy Chairperson of the Community Services Committee:
 - d) Cr S S Virk, as Deputy Chairperson of the Technical Services Committee; and
 - e) Cr P Hetherington, as Deputy Chairperson of the City Audit Committee.

NOTES TO THE STATEMENT OF FINANCIAL ACTIVITY FOR THE PERIOD ENDED 31 MARCH 2025

1 BASIS OF PREPARATION AND SIGNIFICANT ACCOUNTING POLICIES

BASIS OF PREPARATION

This prescribed financial report has been prepared in accordance with the *Local Government Act 1995* and accompanying regulations.

Local Government Act 1995 requirements

Section 6.4(2) of the Local Government Act 1995 read with the Local Government (Financial Management) Regulations 1996, prescribe that the financial report be prepared in accordance with the Local Government Act 1995 and, to the extent that they are not inconsistent with the Act, the Australian Accounting Standards. The Australian Accounting Standards (as they apply to local governments and not-for-profit entities) and Interpretations of the Australian Accounting Standards Board were applied where no inconsistencies exist.

The Local Government (Financial Management) Regulations 1996 specify that vested land is a right-of-use asset to be measured at cost, and is considered a zero cost concessionary lease. All right-of-use assets under zero cost concessionary leases are measured at zero cost rather than at fair value, except for vested improvements on concessionary land leases such as roads, buildings or other infrastructure which continue to be reported at fair value, as opposed to the vested land which is measured at zero cost. The measurement of vested improvements at fair value is a departure from AASB 16 which would have required the City to measure any vested improvements at zero cost.

Local Government (Financial Management) Regulations 1996, regulation 34 prescribes contents of the financial report. Supporting information does not form part of the financial report.

Accounting policies which have been adopted in the preparation of this financial report have been consistently applied unless stated otherwise. Except for cash flow and rate setting information, the financial report has been prepared on the accrual basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and liabilities.

THE LOCAL GOVERNMENT REPORTING ENTITY

All funds through which the City controls resources to carry on its functions have been included in the financial statements forming part of this financial report.

All monies held in the Trust Fund are excluded from the financial statements. A separate statement of those monies appears at Note 15 to these financial statements.

Judgements and estimates

The preparation of a financial report in conformity with Australian Accounting Standards requires management to make judgements, estimates and assumptions that effect the application of policies and reported amounts of assets and liabilities, income and expenses.

The estimates and associated assumptions are based on historical experience and various other factors believed to be reasonable under the circumstances; the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The balances, transactions and disclosures impacted by accounting estimates are as follows:

- estimated fair value of certain financial assets
- impairment of financial assets
- estimation of fair values of land and buildings, infrastructure and investment property
- estimation uncertainties made in relation to lease accounting
- estimated useful life of intangible assets

SIGNIFICANT ACCOUNTING POLICES

Significant accounting policies utilised in the preparation of these statements are as described within the 2024-25 Annual Budget. Please refer to the adopted budget document for details of these policies.





SIGNIFICANT ACCOUNTING POLICIES

Each class of fixed assets within either plant and equipment or infrastructure, is carried at cost or fair value as indicated less, where applicable, any accumulated depreciation and impairment losses.

Assets for which the fair value as at the date of acquisition is under \$5,000 are not recognised as an asset in accordance with Financial Management Regulation 17A (5). These assets are expensed immediately.

expensed immediately. Where multiple individual low value assets are purchased together as part of a larger asset or collectively forming a larger asset exceeding the threshold, the individual assets are recognised as one asset and capitalised.

Initial recognition and measurement for assets held at cost Plant and equipment including furniture and equipment is recognised at cost on acquisition in accordance with Financial Management Regulation 17A. Where acquired at no cost the asset is initially recognise at fair value. Assets held at cost are depreciated and assessed for impairment annually.

Initial recognition and measurement between mandatory revaluation dates for assets held at fair value In relation to this initial measurement, cost is determined as the fair value of the assets given as consideration plus costs incidental to the acquisition. For assets acquired at zero cost or otherwise significantly less than fair value, cost is determined as fair value at the date of acquisition. The cost of non-current assets constructed by the City includes the cost of all materials used in construction, direct labour on the project and an appropriate proportion of variable and fixed overheads.

Trade receivables are recognised at original invoice amount less any allowances for uncollectable amounts (i.e. impairment). The carrying amount of net trade receivables is equivalent to fair value as it is due for settlement within 30 days.

Classification and subsequent measurement

Receivables which are generally due for settlement within 30 days except rates receivables which are expected to be collected within 12 months are classified as current assets. All other receivables such as, deferred pensioner rates receivable after the end of the reporting period are classified as non-current assets.

Trade and other receivables are held with the objective to collect the contractual cashflows and therefore the City measures them subsequently at amortised cost using the effective interest rate method.

A contract is or contains a lease, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. At the commencement date, a right of use asset is recognised at cost and lease liability at the present value of the lease payments that are not paid at that date. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the City uses its incremental borrowing rate.

All contracts classified as short-term leases (i.e. a lease with a remaining term of 12 months or less) and leases of low value assets are recognised as an operating expense on a straight-line basis over the term of the lease.

KEY INFORMATION

Provisions

Provisions are recognised when the City has a present legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Employee Related Provisions

Short-term employee benefits

Provision is made for the City's obligations for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The City's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the calculation of net current assets.

Other long-term employee benefits

The City's obligations for employees' annual leave and long service leave entitlements are recognised as employee related provisions in the statement of financial position.

Long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements for changes in assumptions of obligations for other long-term employee benefits are recognised in profit or loss in the periods in which the changes occur. The City's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the City does not have an unconditional right to defer settlement for at least 12 months after the end of the reporting period, in which case the obligations are presented as current provisions.

Contract liabilities

An entity's obligation to transfer goods or services to a customer for which the entity has received consideration (or the amount is due) from the customer.

Capital grant/contribution liabilities

Grants to acquire or construct recognisable non-financial assets to identified specifications be constructed to be controlled by the City are recognised as a liability until such time as the City satisfies its obligations under the agreement.

Cost Estimate Letter: 2025 Local Government Ordinary Election

As you are aware, the next local government ordinary election will be held on 18 October 2025. This letter is your Cost Estimate for the Western Australian Electoral Commission to conduct your election, should you proceed with making a declaration under the *Local Government Act 1995* for us to do so.

Cost Estimate

The Commission has estimated the cost to conduct your Council's election in 2025 as a postal election at approximately \$340,353 (ex GST).


This cost has been based on the following assumptions:

- The method of election will be postal;
- 7 Councillor(s) vacancies;
- 67000 electors;
- response rate of approximately 35%
- · appointment of a local Returning Officer; and
- count to be conducted at your office using CountWA.

If any of these assumptions are not correct, please contact us and we can provide a new cost estimate.

Cost Methodology

To provide your estimate, the Commission has estimated the costs of all aspects of the election, from supply of materials to staffing costs. For the 2025 Local Government elections, we have applied the following apportionment across the State:



For individual local Governments the exact apportionment of costs may differ slightly from the above, as the cost categories are determined by applying the following variables:

- Envelopes, Printing and Postage, and WAEC Costs are determined by the number of electors in your Local Government;
- Processing and Results is determined by the expected response rate for your election; and
- Returning Officer Costs are determined by the complexity of the election for the Returning Officer; we classify Local Governments into bands depending on a number of factors including number of Wards, number of vacancies and the number of candidates, and then we pay our Returning Officers a rate which reflects this band.

Estimated Cost of 2025 Local Government Elections

The Commission estimates that the total cost of conducting the Local Government Elections across Western Australia in 2025 will increase by \$1.3 million, compared to 2023. The key drivers for this cost increase are as follows:

- a 45% cost increase from Australia Post, comprising of a 25% increase which came into effect in March 2024, and an additional 20% proposed increase currently being considered by the Australian Competition and Consumer Commission, which if approved will take effect in July 2025; and
- a 9% increase in the salaries paid to Returning Officers as required by the Public Sector CSA Agreement 2024.

Variations to the final costs for your Council

In accordance with the *Local Government* (*Elections*) Regulations 1997, the Commission conducts elections on the basis of full accrual cost recovery. This means that should the actual costs incurred to conduct the election be less or greater than what we have estimated, the final cost may differ from the cost estimate you have been provided.

Whilst we aim to keep additional costs at a minimum wherever possible, the following are examples of where cost increases may arise:

- If a Returning Officer is selected that is not local to your area;
- If you elect for Australia Post Priority Service for the lodgement of your election package;
- If casual staff are required for the issuing of Replacement Election Packages;
- If casual staff are required to assist the Returning Officer on election day or night; or
- Unanticipated cost increases from our suppliers.

We will endeavour to keep you informed of any unanticipated cost increases as they are incurred during the election.

Service Commitment

The Commission is committed to conducting elections impartially, effectively, efficiently and professionally. Following each election event, we review our performance and identify ways to improve our service delivery.

The Commission acknowledges that during the 2023 Local Government Ordinary Elections, the results for many Local Governments were delayed. Since this time we have improved our Count Processes, and as demonstrated through extraordinary elections conducted in 2024, we are now able to finalise our results more quickly whilst still retaining accuracy and integrity.

If you have any suggestions for improvements we can make to deliver your election, your feedback is welcome at all times.

Next Steps

Should you wish to accept this cost estimate and proceed with the Electoral Commission undertaking this election, there are specific steps that must be taken under the *Local Government Act 1995*. These steps are summarised in the attached flow chart (Attachment A).

As outlined in the flow chart, if you accept this Cost Estimate then please advise of us this in writing, so that we can issue a Written Agreement letter. Both the Cost Estimate letter, and the Written Agreement letter then need to be taken to Council for a decision.
