I. **CALL TO ORDER**

Chairman, Mr. Scott Simonson, called the hearing to order at 9:32 a.m.

IV. **APPROVAL OF OCTOBER 23, 2025, AND FEBRUARY 10, 2026, MINUTES.**

Mr. Scott Simonson moved to approve the minutes from the October 23, 2025, and February 10, 2026, meeting. Mr. Mickey Freiberg seconded the motion. The motion carried unanimously.

V. **ADJUDICATORY HEARING**

A) LDAF Staff Attorney Bethany Gonzales represented the department and presented the following cases. Assistant Attorney General Tanika Starks presided as Hearing Officer.

ADJUDICATED CASES

26-WM-0221 Elton Express (Elton)

7 VIOLATION(S)

7 – Overcharges – LA. R.S. 3:4617 (A)

Bethany Gonzales, LDAF Attorney, represented the Department. Tanika Starks, Assistant Attorney General, presided over the hearing. Ashley Freyou, store manager, was present and entered a plea of guilty on behalf of the Respondent.

Without objection from Ms. Freyou, LDAF Attorney, Bethany Gonzales, requested to admit into evidence as LDAF 1, the Charge Letter dated January 09, 2026, and as LDAF 5, the notice of inspection dated December 17, 2025.

The Department recommended the Commission to find respondent in violation for seven (7) violations of the Louisiana Weights and Measures, laws, rules and regulations for failing to display a price as required by LAC 7:XXXV.117(A). The Department recommended a penalty of Three Thousand Five Hundred Dollars (\$3,500.00) to be paid within 30 days of receipt of demand letter.

The motion to accept respondent’s guilty plea and assess a penalty of One Thousand Seven Hundred and Fifty Dollars (1,750.00) was made by Mr. Scott Simonson and seconded by Mr. Tommy “Bo” Haring. All members were in favor. The motion carried.

12 VIOLATION(S)

6 - Overcharge Violations – LA. R.S. 3:4617 (A)

6 – Prices Not Displayed – LAC 7:XXXV.117 (A)

Bethany Gonzales, LDAF Attorney, represented the Department. Tanika Starks, Assistant Attorney General, presided over the hearing. No one was present on behalf of the Respondent.

Director Paul Floyd, LDAF Inspector Anna Greathouse, and Program Manager Steven Coco were called as witnesses by the Department.. Paul Floyd identified and authenticated the Charge Letter dated January 9, 2026, admitted into evidence as LDAF 1, and Amended Charge Letter dated February 13, 2026, admitted into evidence as LDAF 1B.

Ms. Anna Greathouse identified and authenticated the price verification summary reports and the Notice of Inspections dated September 22, 2025, October 31, 2025, and December 22, 2025. The summary reports were admitted into evidence as LDAF 2, LDAF 3 and LDAF 5, respectively. Mr. Steven Coco identified and authenticated the warning letter dated October 31, 2025, and it was admitted into evidence as LDAF 4.

The Department recommended the Commission to find respondent in violation for twelve (12) violations of the Louisiana Weights and Measures, laws, rules and regulations for misrepresenting the price or quantity of a commodity and failing to meet the 98% or higher pass rate as required. The Department recommended a penalty of Four Thousand Eight Hundred Dollars (\$4,800.00) to be paid within 30 days of receipt of demand letter.

The motion to find respondent in violation and assess the department recommended penalty of Four Thousand Eight Hundred Dollars (\$4,800) was made by Mr. Justin Alford and seconded by Mr. Frank Lopinto. All members were in favor. The motion carried.

The department recommended a penalty of Six Thousand Dollars. (\$6,000.00). Motion to accept the stipulation and recommended penalty was made by Mr. Tommy “Bo” Haring and seconded by Mickey Freiberg. All members were in favor. Motion carried.

The department recommended a penalty of Four Thousand Three Hundred Dollars. (\$4,300.00). Motion to accept the stipulation and recommended penalty was made by Mr. Bryan Stafford and seconded by Mr. Dave George. All members were in favor. Motion carried.

The department recommended a penalty of Ten Thousand Five Hundred dollars. (\$10,500.00). Motion to accept the stipulation and recommended penalty was made by Mr. Justin Alford and seconded by Kurt Strawitz. All members were in favor. Motion carried.
