The purpose of the report is (1) to provide a guide for private timber owners in determining stumpage prices regionally or statewide, (2) establish annual stumpage price figures for severance tax purposes and (3) determine the timber value for use-value assessment of forest land.

2014 FOURTH QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the fourth quarter of 2014 averaged \$262.72 per thousand board feet Doyle. This average represents a 11.4 percent increase from the previous quarter and 5.73 percent increase compared to a year ago. Prices paid for mixed hardwood sawtimber during the fourth quarter of 2014 averaged \$444.31 per thousand board feet Doyle which is a 6.03 percent increase from the previous quarter and 9.61 percent lower than a year ago. Pulpwood stumpage prices averaged \$24.79 per standard cord for pine and \$37.68 per standard cord for hardwood.
