Director's Report:

Mrs. Peltier gave a staffing update that included a summary of the annual Southern Plant Board meeting, which was held in Wilmington, North Carolina. Louisiana will be hosting the 2026 Southern Plant Board meeting in Baton Rouge, May 4-7. The spring compliance inspection was performed at the positive P. ramorum nursery on May 23, 2025. Due to funding issues, only symptomatic plant tissue will be sampled going forward. An update was given on CAPS surveys. All four schools participating in the beekeeping grant have received the majority of their equipment and bees. Mrs. Peltier gave an update on Citrus Greening found in Lafourche Parish, which is a new parish for citrus greening.
