The purpose of the report is (1) to provide a guide for private timber owners in determining stumpage prices regionally or statewide, (2) establish annual stumpage price figures for severance tax purposes and (3) determine the timber value for use-value assessment of forest land.

2014 THIRD QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the third quarter of 2014 averaged \$235.84 per thousand board feet Doyle. This average represents a 8.73 percent decrease from the previous quarter and 3.60 percent decrease compared to a year ago. Prices paid for mixed hardwood sawtimber during the third quarter of 2014 averaged \$419.05 per thousand board feet Doyle which is a 3.54 percent decrease from the previous quarter and 18.59 percent higher than a year ago. Pulpwood stumpage prices averaged \$24.65 per standard cord for pine and \$30.06 per standard cord for hardwood.
