The current balance in that account is \$130,682.76. The total \$500,000 allocated by the legislature should be in the fund within the next two months. Becky Dupree will provide monthly updates on the account balance to Dr. Heidorn.

2025 Grant Application Recommendations

The board received 34 grant applications, which collectively sought over \$1.8 million dollars.

The board considered the applications received for the 2025 grants, which had already been reviewed and considered by the Equine Board Grant Applications Review Subcommittee at its August 2025 meeting. Dr. Heidorn presented the subcommittee's recommendations to the Board.

MOTION: Marc Browning made a motion to authorize LDAF staff to prioritize disbursement of funds to grant recipients based on the dates of their respective events, in the event that all funding is not immediately available. The motion was seconded by Sky Wright and passed unanimously.

Plans for Next Legislative Session

The board discussed goals and plans for the next legislative session, including possibly requesting that the Legislature to remove the \$500,000 cap on funding, in light of the increasing number of grant applications received and the amount of money requested by grant applicants.

OLD BUSINESS

License Plate Update

Dr. Neely Heidorn provided an update on the Equine Board license plate project. Dr. Heidorn advised that the governor signed a state of emergency regarding Department of Motor Vehicles' computer system. That system is outdated and fails whenever a new plate is put into testing. The Equine Board cannot move forward with the plate until a new computer system is installed at OMV, which will be at least a year from now.

Dr. Neely Heidorn reminded the board members to complete their mandatory Sexual Harassment and Ethics Training.
