2011 THIRD QUARTER MARKET SUMMARY

Stumpage prices paid for pine sawtimber during the third quarter of 2011 averaged \$224.40 per thousand board feet Doyle. This average represents a 1.7 percent decrease from the previous quarter and 7.9 percent decrease compared to a year ago. Prices paid for mixed hardwood sawtimber during the third quarter of 2011 averaged \$375.73 per thousand board feet Doyle which is a 10.2 percent increase from the previous quarter and 14.2 percent higher than a year ago. Pulpwood stumpage prices averaged \$20.79 per standard cord for pine and \$15.10 per standard cord for hardwood.
