GOLF CART USAGE AGREEMENT

The Louisiana Department of Agriculture and Forestry (LDAF) Indian Creek Recreation Area (ICRA) Management reserves the right to deny use of golf carts to anyone who is observed violating any of the rules below.

To maintain a safe and pleasant environment, please review and adhere to the following golf cart policy:

1. **Golf Cart Pass** – A **\$10 daily / \$50 monthly / \$100 annual golf cart pass** is required for all personal golf carts.
2. **Driver Requirements** – All golf cart drivers **must be at least 18 years old** and possess a **valid driver's license**. Each person wishing to drive a golf cart at LDAF ICRA **must register at the office** and provide a copy of their valid driver's license. Any guest that allows their golf cart to be operated by a non-registered and/or non-licensed driver will lose their privilege to use a golf cart at ICRA. No refunds will be given for any permit purchased when the privileges are revoked.
3. **Permit Display** – A permit will be issued upon registration and **must be visibly displayed on the golf cart** at all times while on LDAF ICRA property.
4. **Golf Cart Rules & Safety** – For the safety of all campers, drivers must follow **standard golf cart rules**, including:
 - Traditional, electric golf carts only. Side-by-sides, 4-wheelers, off-road vehicles, high horsepower "golf carts", or the like are not permitted.
 - Golf carts must be in good condition, well-maintained, without damage, and safe to operate.
 - Loud engines or exhausts, noise makers, loud music or thumping bass, loud sounds from deferred maintenance, or the like are prohibited. Golf carts should not interfere with camper's peaceful enjoyment.
 - **Drivers must adhere to posted speed limits at all times.**
 - **Golf carts cannot be driven after dark without operable vehicle mounted headlights.** Holding flashlights or the like is not acceptable.

- Persons on a golf cart cannot exceed the number of legal seats. No standing passengers on the golf cart. Driver cannot have anyone sitting in their lap during the operation of the golf cart.
- Pedestrians have the right of way.
- Management reserves the right to revoke the golf cart privileges of any person who has evidenced a disregard for the rules. In the event that privileges are revoked, camper agrees to remove the golf cart immediately or LDAF ICRA will remove & store it at camper's expense. **No refunds will be given for any permit purchased when the privileges are revoked.**
- Campers and guests of campers agree to use the campground and golf cart at their own risk. LDAF ICRA makes no warranty or representations as to conditions existing or that may hereafter exist upon the campground premises that may affect the use of golf carts.
- LDAF ICRA is not responsible for stolen or damaged golf carts or accidents, damages, injuries, and or deaths of any kind related to the use of a Golf Cart.

Conditional Permission: Permission to have and use a Golf Cart at LDAF ICRA is a privilege and not a contractual right. Such permission is expressly conditional upon my adherence to the terms of these rules and other rules in effect at any given time. I understand that ICRA may revoke such permission at any time for violation of ICRA rules. I acknowledge that the Released Parties shall have no duty, obligation, or liability arising out of the provision of, or failure to revoke permission.

Assumption of Risk: To assume all risks of injury, damage, death, or any other harm to myself and any other person, pet, or property incidental to the use of a golf cart at LDAF ICRA. Using a golf cart is completely voluntary.

I have read the above and agree to abide by all above conditions and rules relating to golf cart use at LDAF ICRA.
